Filamin acts as a key regulator in epithelial defence against transformed cells

Recent studies have shown that certain types of transformed cells are extruded from an epithelial monolayer. However, it is not known whether and how neighbouring normal cells play an active role in this process. In this study, we demonstrate that filamin A and vimentin accumulate in normal cells specifically at the interface with Src- or RasV12-transformed cells. Knockdown of filamin A or vimentin in normal cells profoundly suppresses apical extrusion of the neighbouring transformed cells. In addition, we show in zebrafish embryos that filamin plays a positive role in the elimination of the transformed cells. Furthermore, the Rho/Rho kinase pathway regulates filamin accumulation, and filamin acts upstream of vimentin in the apical extrusion. This is the first report demonstrating that normal epithelial cells recognize and actively eliminate neighbouring transformed cells and that filamin is a key mediator in the interaction between normal and transformed epithelial cells.

Introduction

Cell transformation arises from activation of oncoproteins and/or inactivation of tumour suppressor proteins. At the initial stage of carcinogenesis, transformation occurs in single cells within epithelia, and the transformed cells grow while being surrounded by neighbouring normal epithelial cells. In *Drosophila*, there are a number of reports demonstrating that normal and transformed epithelial cells compete with each other for survival; ‘loser cells’ are extruded from the epithelium or undergo apoptosis, while ‘winner cells’ proliferate and fill the vacant spaces. This process is called “cell competition”¹⁻⁸. However, it was not clearly understood what happens at the interface between normal and transformed epithelial cells in vertebrates. Recently, it has been revealed that certain types of transformed cells are extruded from a monolayer of normal cells and leave the epithelium^{9,10}. For example, we have shown using mammalian cell culture systems that when RasV12-transformed cells are surrounded by normal cells, the RasV12 cells are either apically extruded from the monolayer, or form dynamic basal protrusions and invade the basal matrix⁸. We have also demonstrated that when Src-transformed cells are surrounded by normal cells, Src cells are apically extruded from a monolayer of normal epithelial cells¹¹. Apical extrusion of Src-transformed cells is also observed in the outermost epithelium of zebrafish embryos¹¹. In addition, ErbB2-overexpressing cells are apically translocated into the lumen of epithelia¹². These studies shed light on unexplored processes occurring at the initial step of carcinogenesis.

Although molecular mechanisms for the apical extrusion of transformed cells are largely unknown, we have shown that various signalling pathways are activated in transformed cells surrounded by normal cells, leading to their extrusions^{8,11}. For instance, myosin-II

and Cdc42 are activated in Ras-transformed cells only when they are surrounded by normal epithelial cells⁸. Similarly, myosin-II, mitogen-activated protein kinase, and focal adhesion kinase are activated in Src-transformed cells surrounded by normal cells¹¹. Furthermore, inhibition of these signalling pathways substantially suppresses apical extrusion of the transformed cells. These results indicate that modulation of various signalling pathways in transformed cells plays a crucial role in the apical extrusion. However, it is not known whether and how neighbouring normal cells play an active role in the extrusion of transformed cells.

Filamin is a homodimeric actin-binding protein that crosslinks and stabilizes cortical F-actin filaments and links them to plasma membranes by binding to transmembrane receptors or ion channels¹³⁻¹⁶. A V-shape of filamin dimers causes the perpendicular branching of F-actin, generating dynamic orthogonal F-actin networks rather than parallel actin bundles. There are three filamin homologues: filamin A, B, and C. Filamin A and filamin B are both ubiquitously expressed, whereas filamin C is specifically expressed in muscles. Filamin A is a large, rod-like protein composed of an N-terminal actin-binding domain and 24 immunoglobulin (IgG)-like domains. The actin-binding domain and the first 15 IgG-like domains form an elongated structure that binds actin filaments along its length. The 16-23 IgG-like domains form more compact, globular structures containing cryptic binding sites that are exposed when the molecule is under tension. The C-terminal IgG-like domain is responsible for dimerization. Filamin binds to numerous proteins including transmembrane receptors and signalling molecules, and is involved in various cellular processes such as cell adhesion, cell motility, and transcriptional control. Moreover, a recent study demonstrated that filamin can also play a role in cellular

mechanotransduction¹⁷. Externally imposed shear stress or myosin-II-driven forces induce deformation of F-actin networks, thereby exposing the cryptic sites of filamin A and modulating its affinity for binding partners.

Here, using mammalian cell culture systems, we show that filamin is accumulated in normal epithelial cells at the interface with Src- or Ras-transformed epithelial cells and plays a crucial role in apical extrusion of the transformed cells. Comparable phenomena are also observed in the epithelia of zebrafish embryos. This is the first report demonstrating molecular mechanisms whereby normal epithelial cells actively eliminate neighbouring transformed cells.

Results

Filamin A and vimentin are specifically modulated between normal and Src-

transformed cells. We have previously shown that when oncogenic v-Src- or RasV12-transformed Madin-Darby canine kidney (MDCK) cells are surrounded by normal MDCK cells, the transformed cells are apically extruded from an epithelial monolayer^{8,11}. But when the transformed cells alone are present, they stay in a monolayer, suggesting that the presence of surrounding normal cells induces apical extrusion of the transformed cells. To understand the molecular mechanisms for these phenomena, we have tried to identify molecules that specifically function at the interface between normal and transformed cells. First, cells were cultured under three different conditions: i) normal MDCK cells alone, ii) 1:1 mix culture of normal and Src-transformed MDCK cells, and iii) Src-transformed MDCK cells alone. For Src-transformed cells, we used MDCK cells transformed with a temperature-sensitive v-Src mutant (ts-Src MDCK cells)^{18,19}. We found several molecules that were immunoprecipitated with anti-phospho-tyrosine antibodies predominantly under the mix culture condition (Fig. 1a). Among them, using mass spectrometry we identified the 280 kDa and 55 kDa proteins as filamin A and vimentin, respectively (Fig. 1a, arrow and arrowhead). The identity of these proteins was confirmed by western blotting with anti-filamin or anti-vimentin antibody (Fig. 1b). Western blotting with anti-phospho-tyrosine antibody demonstrated that filamin or vimentin *per se* was not tyrosine phosphorylated and that vimentin specifically bound to tyrosine phosphorylated molecules under the mix culture condition (Supplementary Fig. 1a,b). Furthermore, the interaction between filamin and vimentin was observed only when normal and Src-transformed cells were co-cultured (Supplementary Fig. 1c). These

data suggest that the formation of novel protein complexes specifically occurs when normal and transformed epithelial cells interact with each other.

Filamin in the surrounding cells plays a positive role in apical extrusion of

transformed cells. To investigate the function of filamin at the interface between normal and Src-transformed cells, we first examined subcellular localisation of filamin by immunofluorescence analysis. We found that filamin was accumulated in the surrounding normal cells at the interface with Src cells (Fig. 2a,c,d). When Src activation was not induced, filamin accumulation was not observed (Fig. 2b,d). In addition, when Src cells alone were present, filamin accumulation did not occur (Fig. 2e). These data indicate that surrounding normal cells recognize the presence of Src-transformed cells and accumulate filamin at the interface. We also found comparable filamin accumulation in normal MDCK cells at the interface with RasV12-transformed MDCK cells (Fig. 2f). Filamin was shown to bind orthogonal actin structures, but we did not observe specific actin accumulation in normal cells at the interface with Src-transformed cells (Supplementary Fig. 2a-c). However, when F-actin structures were disrupted by cytochalasin D, linear filamin staining pattern was lost (Fig. 2g, Supplementary Fig. 2d), suggesting that localisation of filamin depends on the intact structure of actin cytoskeletons. To understand functional involvement of the filamin accumulation in apical extrusion of transformed cells, we established filamin A-knockdown MDCK cells (Fig. 2h, Supplementary Fig. 3a,b). Knockdown of filamin A did not affect expression of cell adhesion and cytoskeletal proteins (Supplementary Fig. 3c). When Src cells were surrounded by filamin A-knockdown cells, apical extrusion of Src cells was profoundly

blocked (Fig. 2i and Supplementary Fig. 3d). Similarly, apical extrusion of RasV12-transformed cells was completely blocked when RasV12-transformed cells were surrounded by filamin A-knockdown cells (Fig. 2j). These data indicate that filamin A in the surrounding normal cells plays a crucial role in apical extrusion of the transformed cells.

Filamin plays a crucial role in apical extrusion of v-Src-expressing cells in zebrafish embryos. Furthermore, we examined whether filamin is involved in apical extrusion of Src-activated cells *in vivo*. In a previous study, using zebrafish embryos we showed that v-Src-expressing cells were apically extruded from an outermost epithelial monolayer, enveloping layer (EVL)¹¹. Using an EVL-specific Gal4-driver line, we have established a zebrafish line expressing GFP or GFP-filamin A within the EVL epithelium. We found that GFP-filamin A was substantially accumulated at the interface with v-Src-expressing cells (Fig. 3a)(54% of 76 v-Src-expressing cells from 16 embryos). In contrast, accumulation of GFP was not observed (0% of 29 v-Src-expressing cells from 7 embryos). Moreover, when expression of filamin A was knocked down by morpholino oligonucleotides, apical extrusion of v-Src-expressing cells was significantly suppressed (Fig. 3b and Supplementary Fig. 4a,b), which was rescued by exogenous expression of filamin A (Fig. 3c and Supplementary Fig. 4c). These data suggest that filamin is an evolutionarily conserved key regulator in apical extrusion of transformed cells.

Vimentin accumulation in the surrounding cells is involved in apical extrusion of Src-transformed cells. Vimentin is one of the intermediate filament proteins and is

involved in various cellular processes, such as cell adhesion, cell motility and stress response²⁰⁻²². To understand the function of vimentin at the boundary between normal and Src-transformed cells, we examined subcellular localisation of vimentin. We found that vimentin was also accumulated in the surrounding normal cells at the interface with Src cells (Fig. 4a,c). When Src activation was not induced, vimentin accumulation was not observed (Fig. 4b). To further investigate the interface between normal and Src cells, we performed electron microscopic analyses (Fig. 4d, Supplementary Fig. 5). We found that normal cells produced arm-like extensions as if they held neighbouring Src cells and that intermediate filament-like structures were abundantly present in these extensions (Fig. 4d, Supplementary Fig. 5, arrows). Collectively, these data suggest that normal cells sense the presence of neighbouring Src cells and surround them with intermediate filament-rich protrusions. Next, using MDCK cells stably expressing GFP-vimentin (Supplementary Fig. 6a), we analysed the dynamic rearrangement of vimentin filaments during apical extrusion of Src cells. When Src cells were surrounded by GFP-vimentin-expressing cells, GFP-vimentin was accumulated at the interface with Src cells as observed for endogenous vimentin proteins (Fig. 4e, Supplementary Fig. 6b). Time-lapse analyses revealed that there were two types of vimentin-rich protrusions that dynamically reacted against Src cells. One was the holding arm-like protrusion that surrounded Src cells (Fig. 4f, Supplementary Fig. 7a, Supplementary Movie 1), and the other was the spiky protrusion that poked Src cells (Fig. 4g, Supplementary Movie 2). These protrusions disappeared after Src cells were apically extruded (Fig. 4f, Supplementary Fig. 7a, Supplementary Movie 1). We also found that holding arm-like vimentin accumulations were often accompanied by the basal extension of the neighbouring Src-

transformed cells (Fig. 4f, Supplementary Fig. 7a-c). Time-lapse analyses demonstrated that vimentin filaments were accumulated as if they reacted to basal extensions of transformed cells and that these extensions retracted following the appearance of holding arm-like protrusions, eventually leading to apical extrusion of transformed cells (Fig. 4f, Supplementary Fig. 7a, Supplementary Movie 1). Furthermore, when Src cells were surrounded by vimentin-knockdown cells, apical extrusion and basal extension of Src cells were significantly suppressed and promoted, respectively (Fig. 5a-c, Supplementary Fig. 8a-d). In the previous study, we showed that basal protrusion formation of transformed cells suppresses their apical extrusion⁸. Collectively, these data suggest that holding arm-like protrusions positively regulate apical extrusion of transformed cells, at least partially, by suppressing their basal extensions. To further understand the functional role of the vimentin filaments, we examined their mechanical property. When laser irradiation ablated the holding arm-like filaments at the interface with Src cells, the ends of severed filaments were instantly recoiled from each other (Supplementary Fig. 9a,b, Supplementary Movie 3). In contrast, comparable recoiling was not observed for spiky protrusions (Supplementary Fig. 9c). These results suggest that holding arm-like vimentin filaments generate contractile forces at the interface that could prevent the neighbouring transformed cells from forming basal extensions and possibly squeeze out the transformed cells (For further discussion on physical property of vimentin filaments, see Supplementary Discussion following Supplementary Fig. 9). For RasV12-transformed cells, comparable vimentin accumulation was observed in the surrounding normal cells (Fig. 5d), but vimentin-knockdown did not significantly affect apical extrusion of RasV12-transformed cells. As keratin 5/8 was also accumulated at the interface with

RasV12-transformed cells (Fig. 5e), other intermediate filament proteins may also function at the interface with transformed cells.

Filamin acts as a key regulator in the interaction between normal and transformed

cells. We next examined spatial and functional relationship between filamin and vimentin. We observed that filamin and vimentin partially colocalised at the interface between normal and Src-transformed cells (Fig. 6a), consistent with the result of co-immunoprecipitation of filamin and vimentin (Supplementary Fig. 1c). When Src-transformed cells were surrounded by filamin A-knockdown cells, vimentin accumulation was significantly suppressed (Fig. 6b). In contrast, when Src-transformed cells were surrounded by vimentin-knockdown cells, filamin accumulation was not affected (Fig. 6c). These results suggest that filamin acts, at least partially, upstream of vimentin at the interface between normal and Src-transformed cells. Previous studies suggest that filamin acts upstream of vimentin during cell spreading and that PKC- ϵ is involved in filamin-mediated vimentin phosphorylation that regulates dynamic reorganization of vimentin filaments^{23,24}. We observed that PKC- ϵ was accumulated in normal cells, but not in filamin-knockdown cells, at the interface with Src cells (Fig. 6d), suggesting that filamin regulates accumulation of PKC- ϵ . We also found that phosphorylated vimentin was colocalised with accumulated GFP-vimentin at the interface with Src-transformed cells (Fig. 6e), which was substantially suppressed by the treatment with PKC inhibitor Bisindolylmaleimide (BIM)-I. BIM-I treatment also blocked apical extrusion of Src cells (Fig. 6f) and suppressed vimentin accumulation (Fig. 6g), but did not affect filamin

accumulation (Fig. 6h). Collectively, these data suggest that PKC- ϵ is a potential regulator for filamin-regulated vimentin accumulation.

To explore the upstream regulators of filamin, we examined the effect of various inhibitors on filamin accumulation (Supplementary Table 1). We found that Rho kinase inhibitor Y27632 significantly suppressed filamin accumulation in normal cells at the interface with RasV12- or Src-transformed cells (Fig. 7a,b). When RasV12- or Src-transformed cells were surrounded by cells overexpressing RhoGAP or a dominant negative mutant of Rho kinase, both apical extrusion and filamin accumulation were substantially suppressed (Fig. 7c-j, Supplementary Fig. 10a,b). Overexpression of a dominant negative form of myosin-II (myosin light chain (MLC)-AA) in normal cells surrounding Src-transformed cells did not affect apical extrusion or filamin accumulation (Supplementary Fig. 10c-e). These data indicate that in the surrounding normal cells the Rho/Rho kinase pathway regulates filamin accumulation in a myosin-II-independent manner.

We previously reported that myosin-II was activated in Src- or Ras-transformed cells when surrounded by normal cells and that addition of myosin-II inhibitor blebbistatin or coexpression of MLC-AA in the transformed cells substantially suppressed their apical extrusion^{8,11}. We found that addition of blebbistatin significantly suppressed filamin accumulation in normal cells at the interface with Src-transformed cells (Fig. 8a). In addition, expression of MLC-AA in Src- or Ras-transformed cells significantly suppressed filamin accumulation in the surrounding normal cells (Fig. 8b-d). These data suggest that the activation of myosin-II in transformed cells influences localisation and function of filamin in the neighbouring normal cells. It has been reported

that myosin-II activity affects various cellular mechanical properties^{25,26}. Thus, we next performed atomic force microscopic analyses and found that Ras-transformed cells had higher elasticity than normal cells, and coexpression of MLC-AA significantly suppressed it (Supplementary Fig. 11)⁸, indicating that enhanced myosin-II activity leads to increased cellular elasticity in the transformed cells. Together with the previous study showing that filamin acts as mechanosensor/transducer¹⁷, these data support the notion that normal cells sense and respond to mechanical environments modulated by myosin-II-driven forces in the neighbouring transformed cells and that filamin plays a crucial role in this process.

Discussion

In this study, we demonstrate the molecular mechanisms whereby normal epithelial cells actively eliminate neighbouring transformed cells from the epithelium. We present several data indicating that filamin is a key mediator in the interaction between normal and transformed epithelial cells. First, in mammalian cultured cells, filamin accumulates in normal epithelial cells at the interface with Src- or Ras-transformed cells. Knockdown of filamin in normal epithelial cells profoundly suppresses apical extrusion of the neighbouring transformed cells. Second, in the EVL epithelium of zebrafish embryos, filamin is accumulated around v-Src-expressing cells, and knockdown of filamin significantly diminishes their apical extrusion. Third, the Rho/Rho kinase pathway regulates filamin accumulation, and filamin acts upstream of vimentin filaments that dynamically react against transformed cells. These data indicate that filamin plays a vital role in apical extrusion of transformed cells.

Laser ablation experiments revealed that pulling forces are exerted on the interface between normal and transformed cells (Supplementary Fig. 12, Supplementary Movies 4-6). When transformed cells are surrounded by normal cells, myosin-II activity is enhanced and the transformed cells become round and tall, suggesting the elevated tensile forces within the transformed cells^{8,11}. Furthermore, reduction of myosin-II activity in the transformed cells diminishes these morphological changes⁸. Collectively, the pulling forces at the interface are likely to be mediated by enhanced myosin-II activity in the transformed cells, which would physically drive the apical extrusion process. In addition, vimentin filaments in the neighbouring normal cells may also play a role in this process. When Src cells are surrounded by vimentin-knockdown cells, formation of p-MLC-

enriched basal protrusions is significantly promoted, and instead p-MLC is downregulated along the lateral membranes (Supplementary Fig. 8d); thus the presence of vimentin filaments in normal cells substantially influences the localization of p-MLC in the neighbouring transformed cells. The molecular mechanism underlying this process is not clear at present, which needs to be elucidated in future studies.

Within epithelia of *Drosophila* and mammals, normal and transformed cells have been shown to compete with each other for survival; Either of them are extruded from the epithelium or undergo apoptosis, while the other proliferate and fill the vacant spaces^{9,10,27-29}. These phenomena potentially reflect the events occurring at the initial stage of carcinogenesis, however the molecular mechanisms, especially for cell extrusion, are still largely unknown. Previous studies showed that when Ras- or Src-transformed cells are surrounded by normal cells, various proteins such as myosin-II, MAPK, Cdc42, N-WASP are upregulated in transformed cells, leading to their apical extrusion^{8,11,30}. In addition, upregulation of MAPK and matrix metalloproteinases in ErbB2-overexpressing cells is involved in their apical translocation¹². In the imaginal disc epithelium of *Drosophila*, activity of Rho1 and JNK in Src-activated cells is engaged in their extrusion^{7,31}. These results indicate that multiple signalling pathways modulated in the transformed cells are implicated in their elimination from epithelia. However, it remained elusive whether and how normal cells actively influence the fate of neighbouring transformed cells. Here we show that filamin is a key regulator in normal epithelial cells to eliminate transformed cells. This is the first report demonstrating the molecular mechanism whereby normal epithelial cells play an active role in apical extrusion of transformed cells (Fig. 9). Our results imply a notion that at the early stage of

carcinogenesis, normal epithelial cells act as “immunity” against transformed cells; here we name this process as EDAC (Epithelial Defence Against Cancer). By further developing this new research field, we would create a novel type of cancer treatment: eradication of transformed cells by enhancing a defensive force of neighbouring normal epithelial cells.

Methods

Antibodies, Plasmids and Materials. Mouse anti-phospho-tyrosine (clone 4G10; 05-1050), mouse anti-actin (MAB1501R), mouse anti-myc-tag (clone 4A6;05-724), mouse anti-GAPDH (MAB374) and rabbit anti-integrin β 3 (04-1060) antibodies were from Merck Millipore. Mouse anti-phospho-tyrosine (P-Tyr-100; 9411)), rabbit anti-vimentin (5741) and rabbit anti-phospho-myosin light chain 2 (Thr18/Ser19; 3674) antibodies were from Cell Signaling Technology. As to anti-phospho-tyrosine antibodies, clone 4G10 was used for western blotting, and a mixture of the two antibodies was used for immunoprecipitation. Mouse anti-vimentin (clone V9; V6389) and mouse anti-filamin (F6682) antibodies were from Sigma-Aldrich. Mouse anti-integrin β 1 (610467), mouse anti-E-cadherin (610182), mouse anti-N-cadherin (610920) and mouse anti- β -catenin (610153) antibodies were from BD biosciences. Rabbit anti-phospho-vimentin (Ser38; ab52942) and mouse anti-PKC ϵ (ab114034) antibodies were from Abcam. Mouse anti-GFP (11814460001) antibody was from Roche Diagnostics. Rabbit anti-pY418-Src (44660G) antibody was from Life Technologies. Mouse anti-mCherry (632543) antibody was from Clontech. Mouse anti-keratin K5/K8 (65131) antibody was from PROGEN Biotechnik GmbH. For Fig. 6a, Alexa-Fluor-568-conjugated anti-vimentin antibody was prepared using Zenon[®] Mouse IgG Labeling Kit (Life Technologies) according to the manufacturer's instructions. Alexa-Fluor-488-, -568- or -647-conjugated phalloidin (Life Technologies) was used at 1.0 U ml⁻¹. Alexa-Fluor-488-, -568- and -647-conjugated secondary antibodies were from Life Technologies. Hoechst 33342 (Life Technologies) was used at a dilution of 1:5,000. For immunofluorescence, all primary antibodies were used at 1:100, except for anti-PKC ϵ and anti-phospho-myosin light chain 2 antibodies

that were used at 1:50, and all secondary antibodies were used at 1:200. To construct pEGFP-N1-vimentin, the cDNA of human vimentin was obtained from Addgene and inserted into pEGFP-N1. To construct pcDNA/TO/GFP-MLC-AA, the cDNA of MLC-AA was amplified from pEGFP-N1-MLC-AA (gift from H. Hosoya) by PCR, and inserted into the XhoI/EcoRI site of pcDNA/TO/GFP³². To construct pmCherry-N1-MLC-AA, the cDNA of MLC-AA was inserted into the EcoRI/KpnI site of pmCherry-N1 (gift from R. Y. Tsien). pcDNA/TO/Cherry-p50RhoGAP catalytic domain was as previously described⁸. pEF-BOS-myc-Rho kinase RB/PH (TT) (a dominant negative mutant) was provided by K. Kaibuchi. Type-I collagen (Cellmatrix Type I-A) was obtained from Nitta Gelatin and was neutralized on ice to a final concentration of 2 mg ml⁻¹ according to the manufacturer's instructions. To fluorescently stain living MDCK, ts-Src MDCK or MDCK-pTR GFP-RasV12 cells, CMTPIX (red dye) or CMFDA (green dye) (Life Technologies) was used according to the manufacturer's instructions. The following inhibitors, Bisindolylmaleimide (BIM) -I (10 µM), CK666 (100 µM), (S)-(-)-blebbistatin (30 µM), KT5720 (4 µM), IPA-3 (40 µM), Smifh2 (25 µM) and Y27632 (20 µM) were from Calbiochem. U0126 (40 µM) was from Promega. Cytochalasin D (4 µM) was from Sigma-Aldrich.

Cell Culture

MDCK and ts-Src MDCK cells were from W. Birchmeier¹⁹ and were cultured as previously described^{8,11}. MDCK-pTR GFP-RasV12 cells were cultured in Dulbecco's modified Eagle's medium (DMEM) containing 10% FCS (tetracycline-free), penicillin/streptomycin, 5 µg ml⁻¹ of blasticidin (Invivogen) and 400 µg ml⁻¹ of

zeocin (Invivogen)⁸. MDCK cells stably expressing YFP-actin (gift from J. Rosenblatt) were cultured as MDCK cells except that 800 $\mu\text{g ml}^{-1}$ of G418 (Calbiochem) was added to the medium. To establish MDCK cells stably expressing GFP-vimentin or myc-Rho kinase RB/PH (TT), MDCK cells were transfected with pEGFP-N1-vimentin or pEF-BOS-myc-Rho kinase RB/PH (TT) using LipofectamineTM 2000 (Life Technologies) according to the manufacturer's instructions, followed by selection in medium containing 800 $\mu\text{g ml}^{-1}$ of G418. For establishing cell lines stably expressing myc-Rho kinase RB/PH (TT), pcDNA-FLAG was co-transfected to induce neomycin-resistance. MDCK cells stably expressing filamin A shRNA or vimentin shRNA in a tetracycline-inducible manner were established as follows; filamin A shRNA oligonucleotides (filamin A shRNA-1: 5'-

CCATCGGG-3') were cloned into the BglIII and XhoI site of pSUPERIOR.neo+gfp
(Oligoengine). MDCK-pTR cells⁸ were transfected with pSUPERIOR.neo+gfp filamin A
shRNA or vimentin shRNA using Lipofectamine™ 2000, followed by selection in
medium containing 5 µg ml⁻¹ of blasticidin and 800 µg ml⁻¹ of G418. To establish MDCK
cells stably expressing GFP-MLC-AA or mCherry-p50RhoGAP catalytic domain in a
tetracycline-inducible manner, MDCK-pTR cells were transfected with pcDNA/TO/GFP-
MLC-AA or pcDNA/TO/mCherry-p50RhoGAP catalytic domain as described above,
followed by selection in medium containing 5 µg ml⁻¹ of blasticidin and 400 µg ml⁻¹ of
zeocin. To establish MDCK-pTR GFP-RasV12 cells stably expressing mCherry-MLC-
AA, MDCK-pTR GFP-RasV12 cells were transfected with pmCherry-N1-MLC-AA as
described above, followed by selection in medium containing 5 µg ml⁻¹ of blasticidin, 400
µg ml⁻¹ of zeocin and 800 µg ml⁻¹ of G418. For tetracycline-inducible MDCK cell lines, 2
µg ml⁻¹ of tetracycline (Sigma-Aldrich) was used to induce expression of proteins or
shRNAs. All inhibitors were added at the beginning of the experiments for 12-24 h
incubation, except that Cytochalasin D was added for 1 h prior to fixation. BIM-I was
replaced every 12 h for 24 h. For Fig. 8b, MDCK cells were seeded on collagen-coated
coverslips in 35-mm dishes (Greiner-Bio-One) at a density of 1.0 X 10⁶ cells and
incubated for 24 h. Cells were then transiently transfected with pSG-v-Src¹⁹ and/or
pmCherry-N1-MLC-AA using Lipofectamine™ 2000 (Life Technologies) and were
analysed after 18 h. For Figs 5b, c, 6c, and Supplementary Fig. 8c, d, MDCK-pTR
vimentin-shRNA1 or -shRNA2 cells were incubated with tetracycline for 72 h prior to

induction of v-Src activation. For Figs 2i, j, 6b, d and Supplementary Fig. 3b, to induce sufficient knockdown of filamin A protein, MDCK-pTR filamin A-shRNA1 cells were incubated with tetracycline for 48 h prior to induction of v-Src activation or RasV12 expression. Similarly, for Supplementary Fig. 3d, MDCK-pTR filamin A-shRNA2 cells were incubated with tetracycline for 72 h prior to induction of v-Src activation.

Immunoprecipitation and Western Blotting

For immunoprecipitation, MDCK and ts-Src MDCK cells were trypsinized and plated at a density of 1.6×10^7 cells in 14.5-cm dishes (Greiner-Bio-One) and cultured at 40.5°C for 9 h until a monolayer was formed. Src activation was then induced at 35°C for 14 h. Cells were washed with ice-cold PBS containing 1 mM Na_3VO_4 and lysed for 30 min in Triton X-100 lysis buffer (20 mM Tris-HCl [pH 7.5], 150 mM NaCl, 1% Triton X-100, 1 mM Na_3VO_4 and 10 mM NaF) containing $5 \mu\text{g ml}^{-1}$ leupeptin, 1 mM phenylmethylsulfonyl fluoride and 7.2 trypsin inhibitor units of aprotinin. After centrifugation at $21,500 \times g$ for 10 min, the supernatants were subjected to immunoprecipitation for 1 h with Dynabeads[®] Protein G (Life Technologies) conjugated with a mixture of anti-phospho-tyrosine antibodies (clone 4G10 and P-Tyr-100; 5 μg each). Immunoprecipitated proteins were subjected to sodium dodecyl sulfate-polyacrylamide gel electrophoresis (SDS-PAGE), followed by SYPRO[®] Ruby protein gel staining (Life Technologies) or western blotting with the indicated antibodies. SYPRO Ruby protein staining was performed according to the manufacturer's instructions. Western blotting was performed as previously described³³. Primary antibodies were used

at 1:1,000 except anti-GAPDH at 1:2,000. Stained gels and western blotting data were analysed using ImageQuant™ LAS4010 (GE healthcare).

Time-Lapse Microscopy and Immunofluorescence

For time-lapse analyses, MDCK or ts-Src MDCK cells were fluorescently labelled, mixed with MDCK cells stably expressing GFP-vimentin at a ratio of 1:50, and seeded on the collagen matrix as previously described^{8,11}. The mixture of cells was incubated at 40.5°C for 8-12 h until a monolayer was formed, and was observed at 35°C by Olympus IX81 microscope with the FV1000 system equipped with Z focus drift compensating system, followed by analyses using Olympus FV10-ASW or Volocity software (Improvision). For immunofluorescence, MDCK-pTR GFP-RasV12 or ts-Src MDCK cells were stained with CMTPIX or CMFDA, mixed with the indicated non-stained cells at a ratio of 1:50, and cultured on the collagen matrix as previously described⁸. For analyses of ts-Src MDCK cells, the mixture of cells was incubated for 8-12 h at 40.5°C until a monolayer was formed, followed by v-Src activation at 35°C for 12 h except for analyses of apical extrusions that were examined after 24 h of v-Src activation and for immunofluorescence of PKCε that were examined after 10 h of v-Src activation. For analyses of MDCK-pTR GFP-RasV12 cells, the mixture of cells was incubated for 8-12 h, followed by tetracycline treatment for 16 h except for analyses of apical extrusions that were examined after 24 h of tetracycline treatment. Cells were fixed in methanol for 2.5 min at -20°C except that for Figs 4c, 6d, Supplementary Figs 2a, b, d, 7b, c, 8d and 9b, cells were fixed with 4% paraformaldehyde (PFA) in PBS and permeabilized as previously described¹¹. Immunofluorescence images were analysed by Leica TCS SPE confocal

microscope system and Leica Application Suite (LAS), or Olympus FV1000 system and Olympus FV10-ASW software. Images were quantified by MetaMorph software (Molecular Devices).

Electron Microscopy

The mixtures of ts-Src MDCK cells and MDCK or MDCK GFP-vimentin cells were prepared and cultured in collagen gel-coated, photo etched grid-glass bottom dishes (MatTek Corporation) as described in “Time-lapse microscopy and immunofluorescence”. Briefly, after 12 h of v-Src activation, cells were fixed primarily in 4% PFA before target cells were identified and documented by fluorescence and DIC imaging. Cells were then fixed in PFA/glutaraldehyde, secondarily fixed with osmium tetroxide/potassium ferricyanide before being dehydrated and embedded in EPON. Serial ultrathin sections were stained with lead citrate before being visualized and imaged in a Tecnai Spirit G2 120 kV TEM (FEI) coupled to a Morada CCD camera (Olympus SIS).

Protein Identification by Mass-Spectrometry

Protein bands were excised from the gel, and the protein was identified by peptide mass fingerprinting (PMF) and post-source decay (PSD) MS/MS analysis. Briefly, protein bands were digested in-gel by trypsin gold (Promega) after reductive S-alkylation with dithiothreitol and iodoacetamide. After incubation at 37°C for 12 h, tryptic peptides were purified by ZipTip mC18 (Millipore). High-purity alpha-cyano-4-hydroxycinnamic acid (Shimadzu GLC) was used as MALDI matrix. Mass spectrometric analysis was performed by AXIMA Performance MALDI-TOF/TOF MS (Shimadzu Corporation).

The acquisition mass range was 700-4000 Da. Mass spectrometer was first externally calibrated by angiotensin II (m/z 1046.54) and ACTH fragment 18-39 (m/z 2465.20), and each result was internally calibrated by tryptic autolysis fragment (m/z 842.51 and 2211.10). The peak processing of peptide mass spectra and MS/MS ion selection were analysed by Launchpad version 2.9.1 (Shimadzu), and protein was identified against NCBI non-redundant canis familiaris database (2011_11, 16,245,521 sequence entries) on Mascot Server version 2.3 (Matrix Science), up to one missed cleavage, peptide tolerance of 0.2 Da, fixed modifications of cysteine carbamidomethylation, and variable modifications of methionine oxidation. MOWSE scores of PMF above 56 were considered significant ($P < 0.05$) and ion scores of MS/MS above 28 were indicated identity or extensive homology ($P < 0.05$).

Data Analyses

For data analyses, one-tailed Student's t -tests were used to determine P -values except Fig. 4e where two-tailed Fisher's Exact Test was used and Supplementary Fig. 12b where Welch's t -test was used. For quantification of apical extrusion or immunofluorescence intensity of Src- or RasV12-transformed cells, 1-3 Src-transformed cells or 2-8 RasV12-transformed cells that were surrounded by the indicated cells were analysed. For ts-Src MDCK cells, more than 50 cells were analysed for each experimental condition. For RasV12-MDCK cells, more than 50 cells were analysed for filamin accumulation or more than 120 cells were analysed for apical extrusion, except for Fig. 2j where the number of RasV12-MDCK cell colonies in which the majority ($\geq 75\%$) of RasV12 cells were apically extruded was counted (n=60 colonies from two independent experiments).

Filamin accumulation in the surrounding cells at the interface with Src- or RasV12-transformed cells was quantified per transformed cell. Apical extrusion was analysed by confocal microscopy. For Fig. 2d, $n=107$ for Src-transformed MDCK cells and $n=63$ for MDCK cells from 2-5 independent experiments. For Fig. 5c, to analyse basal extensions of Src-transformed cells, the number of p-MLC-enriched basal extensions below neighbouring cells were quantified. For Fig. 6b, to quantify diminished vimentin accumulation in filamin A-knockdown cells, immunofluorescence intensity of two vimentin-accumulated spots (36 pixels each) per surrounded Src-transformed cell was quantified. When the average of the intensity from the two spots was higher than the average of that in all tetracycline-negative images, the cell was counted as vimentin accumulation-positive. Vimentin accumulation around more than 35 Src cells was quantified in each experiment. tet (-); $n=134$, tet (+); $n=145$ from three independent experiments. For Fig. 6c, filamin accumulation in vimentin-knockdown cells was analysed in a similar way as described above except that two filamin-accumulated spots (16 pixels each) were analysed. tet (-); $n=146$, tet (+); $n=124$ from three independent experiments. For Supplementary Fig. 2c, the fluorescence intensity of YFP-actin in MDCK YFP-actin cells at the interface with normal or Src-transformed MDCK cells was analysed. For each surrounded normal or Src-transformed cell, fluorescence intensity of 4 spots (48 pixels each) in MDCK YFP-actin cells was quantified. More than 20 normal or Src-transformed cells were analysed in each experiment. YFP-actin:MDCK=50:1; $n=69$, YFP-actin:Src=50:1; $n=82$ from three independent experiments.

For Fig. 3b, 275 cells from 10 embryos for control MO and 219 cells from 9 embryos for filamin MO1 were analysed. For Fig. 3c, 417 cells from 12 embryos for control

MO+GFP, 326 cells from 10 embryos for filamin MO1+GFP and 449 cells from 12 embryos for filamin MO1+GFP-filamin were analysed. For Supplementary Fig. 4b, 478 cells from 12 embryos for control MO and 391 cells from 12 embryos for splice MO2 were analysed.

Transgenic Lines, Microinjection and Confocal Imaging of Zebrafish Embryos

To generate an enveloping layer (EVL)-specific tamoxifen-inducible Gal4-driver line, we replaced the Gal4 sequence of pBR-Tol2-krt18:Gal4¹¹ with a fusion protein of the fish-optimized Gal4 KalTA4³⁴ and ERT2 (gift from J. Brickman), KalTA4-ERT2. We generated a UAS:GFP-filamin line by placing GFP-tagged human filamin downstream of 5 copies of the UAS sequence (5xUAS)³⁵. The cDNA of human filamin A was obtained from DsRed2-filamin A (gift from M. Ikebe). The transgenic lines were generated using the Tol2 system³⁶. We used the UAS:GAP43-GFP line¹¹ as a negative control. To visualize cells expressing v-Src, we employed a membrane-Cherry-tagged version of v-Src through the self-cleaving 2A sequence under the control of 5xUAS¹¹. Embryos were injected with the v-Src construct (10-20 pg) and Tol2 RNA (20 pg) into the cell at one-cell stage, and treated with 0.5 μ M 4-hydroxy tamoxifen (4-OHT, Sigma H7904, a stock of 5 mM in ethanol) at 60% epiboly. The embryos were fixed in 4% PFA at 4 h after induction, and were mounted in 1% low-melting agarose for confocal analyses. Confocal images were taken using a 40x water-immersion lens on Leica DM2500 microscope with the TCS SPE system, and were analysed using the Volocity software (Perkin-Elmer). For knockdown experiments in zebrafish, we utilized two anti-sense morpholinos (MOs) against *filamin A* gene: 5'-CGGGTCTCCTGCACTAATTCGCTGT-3' (translational-

blocking MO1) and 5'-ACCTGCACAGCAGAGAGCAATACCC-3' (splice-blocking MO2). The splice MO2 was designed against Exon5, and was validated by RT-PCR for the presence of an aberrant splice form. We used a standard control MO from Gene Tools: 5'-CCTCTTACCTCAGTTACAATTTATA-3'. The MOs (8 ng) were injected into the yolk at the two-cells stage following injection of the v-Src construct.

Atomic Force Microscopy

A commercial AFM (MFP-3D; Asylum Research) with a rectangular cantilever (BL-AC40TS-C2, ~ 0.1 N/m; Olympus) was used to examine the rheology of MDCK, RasV12-MDCK and RasV12-MLC-AA-MDCK cells. The AFM was mounted on an inverted optical microscope (TE-2000E; Nikon). A colloidal silica bead with a radius R of ~ 2.5 μm (Funakoshi) was attached to the apex of the tip with epoxy³⁷. Prior to cell experiments, the spring constant of the cantilever was determined using a built-in thermal fluctuation procedure. For force modulation measurements, the cells around cell-cell contact sites were indented for ~ 30 s at an initial loading force of less than 650 pN. During indentation, a reference signal voltage containing several sinusoidal oscillations in the frequency range of $f = 5\text{--}100$ Hz with an amplitude of 10 nm was applied to a z-axis piezo actuator to move the cantilever in the direction normal to the sample surface. The amplitude and phase shift of the cantilever displacement with respect to the reference signal were measured using a digital lock-in amplifier (7260; SEIKO EG&G Co). The complex shear modulus G^* of cells was estimated according to previous procedures^{37,38}. The storage G' and loss G'' moduli of single cells as a function of f were fitted to the

power-law structural damping model with additional Newtonian viscosity³⁹, which is given by

$$G^* = G' + iG'' = G_0 g(\alpha) \{1 + i\eta(\alpha)\} (f/f_0)^\alpha + i\mu f. \quad (1)$$

Here, G_0 is a scale factor of the modulus at a frequency scale factor f_0 , which was arbitrarily set to 1 Hz. α is the power-law exponent. The $g(\alpha)$ is $\Gamma(1-\alpha) \cos(\pi\alpha/2)$ where Γ denotes the gamma function. The hysteresivity $\eta(\alpha)$ is equivalent to $\tan(\pi\alpha/2)$, and μ is the Newtonian viscous damping coefficient. G_0 exhibits a log-normal distribution and is positively correlated with the apparent Young's modulus by AFM force curve measurements³⁷. If α approaches zero, the cell is perfectly elastic. If α approaches unity, the cell follows the Newton's law of viscous deformation³⁹. The power-law rheological parameters of $\ln G_0$, α and μ of single cells estimated from eq. 1 are shown in Supplementary Fig. 11. The significant difference of those parameters among types of cells shown in Supplementary Fig. 11 remained unchanged even measured at the centre of cells.

Laser Ablation

The mixtures of the indicated cells were seeded on collagen gel-coated glass-bottom dish and incubated as described in "Time-Lapse Microscopy and Immunofluorescence". A 2-photon laser tuned to the 880 nm wavelength (Chameleon; Coherent) irradiated an inner region of the cell (approximately $10 \mu\text{m}^2$). The duration of the stimulus was 100 ms with an approximate power of 115 mW at the surface of the objective lens. In parallel with the ablation, images were acquired at 2 s intervals on an inverted multi-photon microscope (A1MP; Nikon) equipped with a Nikon 40x/NA1.15 Apo LWD water-immersion

objective. For measuring mechanical stress in vimentin filaments, a 2-photon laser was used in point-scan mode (0.062 $\mu\text{m}/\text{pixel}$). The duration of the stimulus was 30 ms with an approximate power of 105 mW. Other settings were same as the cell ablation experiment. Data were analysed by using ImageJ. For Supplementary Fig. 9a, recoil velocity was calculated by measuring the distance between severed ends of laser irradiated GFP-vimentin filaments at 0 s and 18 s after laser irradiation. Eleven areas where GFP-vimentin was accumulated around ts-Src MDCK cells were analysed.

Figure legends

Figure 1 | Identification of proteins that are specifically modulated when normal and Src-transformed cells interact with each other. (a) SYPRO ruby staining (8% SDS-PAGE) of immunoprecipitated proteins with a mixture of anti-phospho-tyrosine antibodies. The arrow and arrowhead indicate the band for filamin A and vimentin, respectively. (b) Validation of the bands for filamin (upper panels) and vimentin (lower panels) by western blotting. The asterisk indicates heavy chains of IgG. Note that identification or validation of the other bands has not been completed yet.

Figure 2 | Filamin accumulation in the surrounding normal epithelial cells plays a crucial role in apical extrusion of transformed cells. (a-c) Immunofluorescence images of filamin (red) in the mix culture of normal and ts-Src MDCK cells. ts-Src MDCK cells stained with CMFDA (green) were surrounded by normal MDCK cells. v-Src activation was induced at 35°C (a,c) or not induced at 40.5°C (b). The area in the white box is shown at higher magnification in the lower panel. Arrows indicate filamin accumulation. (d) Quantification of the filamin accumulation. Data are mean $\pm$ s.e. from three independent experiments. $*P=2.7 \times 10^{-4}$ (Student's *t*-test). (e) Immunofluorescence images of filamin (red) in the mix culture of Src-transformed cells stained with CMFDA (green) and non-labelled Src-transformed cells. (f) Immunofluorescence images of filamin (red) in the mix culture of normal and RasV12-MDCK cells. RasV12-MDCK cells stained with CMFDA (green) were surrounded by normal MDCK cells. GFP-RasV12 expression was not induced (left panels) or induced by tetracycline (right panels). The area in the white box is shown at higher magnification in the lower panel. Arrows

indicate filamin accumulation. White dashed lines in xy panels denote the cross-sections represented in xz panels (**c,f**). (**g**) Effect of cytochalasin D on filamin accumulation in the surrounding normal cells at the interface with Src-transformed cells. ts-Src-MDCK cells stained with CMFDA (green) were mixed with normal cells, and were treated with DMSO or cytochalasin D followed by immunofluorescence with anti-filamin antibody (red). Arrows or arrowheads indicate intact or disturbed filamin accumulation, respectively. Scale bars, 10 μm (**a-c,e-g**). (**h**) Establishment of MDCK cells stably expressing filamin A shRNA1 in a tetracycline-inducible manner. Knockdown was induced for 72 h with tetracycline treatment, followed by western blotting with the indicated antibodies. Note that there are three mammalian filamin homologues (filamin A, B and C), but the majority of filamin proteins in MDCK cells detected by the anti-filamin antibody is filamin A. (**i,j**) Effect of knockdown of filamin A in the surrounding cells on apical extrusion of Src (**i**)- or RasV12 (**j**)-transformed cells. Data are mean $\pm$ s.d. from three (**i**) or two (**j**) independent experiments. $*P=1.2 \times 10^{-4}$, $**P=0.0031$ (Student's *t*-test).

Figure 3 | Filamin plays a crucial role in apical extrusion of v-Src-expressing cells in the enveloping layer of zebrafish embryos. (**a**) Confocal images of a GFP-filamin-expressing zebrafish embryo (at 10-11 h post-fertilization) expressing v-Src in a mosaic manner. Embryos from an EVL-specific GFP-filamin A-expressing line were injected with the UAS:Cherry-v-Src-expressing vector at the one-cell stage. Arrows indicate GFP-filamin accumulation in the neighbouring EVL cells at the interface with v-Src-expressing EVL cells (red). White dashed lines in xy panels denote the cross-sections

represented in xz panels. **(b)** Effect of filamin morpholino oligonucleotides (MO) on apical extrusion of v-Src-expressing cells. Embryos were injected with the v-Src-expressing vector and indicated oligonucleotides. Representative images were shown on the right. Arrowheads indicate v-Src-expressing extruded cells. Data are mean $\pm$ s.e. from 10 embryos for control MO and from 9 embryos for filamin MO1. $*P=1.0 \times 10^{-5}$ (Student's *t*-test). Scale bars, 10 μ m **(a)**, 20 μ m **(b)**. **(c)** Rescue of the effect of filamin MO on apical extrusion by expression of exogenous filamin A. Embryos were injected with the v-Src-expressing vector, indicated oligonucleotides and vector. Note that v-Src and GFP-filamin were specifically expressed in the EVL. Data are mean $\pm$ s.e. from 12 embryos for control MO+GFP, from 10 embryos for filamin MO1+GFP and from 12 embryos for filamin MO1+GFP-filamin. $*P=0.0023$, $**P=0.0024$ (Student's *t*-test).

Figure 4 | Vimentin accumulates in the surrounding normal epithelial cells at the interface with Src-transformed cells. **(a-c)** Immunofluorescence images of vimentin (red) in the mix culture of normal and ts-Src MDCK cells. ts-Src MDCK cells stained with CMFDA (green) were surrounded by normal MDCK cells. v-Src activation was induced at 35°C **(a,c)** or not induced at 40.5°C **(b)**. The area in the white box is shown at higher magnification in the lower panel. Arrows indicate vimentin accumulation in normal MDCK cells at the interface with ts-Src MDCK cells. The white dashed line in the xy panel denotes the cross-sections represented in the xz panel **(c)**. **(d)** Electron microscopic images of the interface between normal and ts-Src MDCK cells. The xy images on the apical or basal slice are presented. A Src-transformed cell is traced by the white-dashed line. A purple cell indicates a neighbouring normal cell that produces the

specific extension along the Src-transformed cell. The area in the white box is shown at higher magnification in the lower panel. Arrows indicate the accumulation of intermediate filament-like structures. (e) Quantification of GFP-vimentin accumulation around Src-transformed cells using time-lapse microscopy. MDCK GFP-vimentin cells were co-cultured with normal or ts-Src MDCK cells. GFP-vimentin accumulation was analysed for 15 h after the temperature shift. $*P = 1.6 \times 10^{-30}$ (Fisher's Exact Test). (f) Dynamic movements of vimentin-rich protrusions from normal cells towards the neighbouring Src-transformed cells. Images are extracted from a representative time-lapse analysis. ts-Src MDCK cells (stained with CMTPX, red) were mixed with MDCK GFP-vimentin cells. Yellow arrowheads indicate basal extension of a Src-transformed cell. White dashed lines delineate a Src-transformed cell. The presented time in each image indicates the duration of v-Src activation. (g) Dynamic movements of vimentin-rich "spiky" protrusions from normal cells towards the neighbouring Src-transformed cells. Arrows and arrowheads indicate "holding arm-like protrusions" and "spiky protrusions", respectively (f,g). Scale bars, 10 μm (a-c,f,g).

Figure 5 | Vimentin regulates the fate of Src-transformed cells surrounded by normal epithelial cells. (a) Establishment of MDCK cells stably expressing vimentin shRNA1 in a tetracycline-inducible manner. Knockdown was induced for 72 h with tetracycline treatment, followed by western blotting with the indicated antibodies. (b) Effect of knockdown of vimentin in the surrounding cells on apical extrusion of Src-transformed cells. Data are mean $\pm$ s.e. from three independent experiments. $*P=0.0058$ (Student's *t*-test). (c) Effect of knockdown of vimentin in the surrounding cells on basal

extension of Src-transformed cells. Data are mean $\pm$ s.e. from three independent experiments. * $P=0.013$ (Student's t -test). **(d)** Immunofluorescence images of vimentin (red) in the mix culture of normal and RasV12-transformed cells. RasV12-MDCK cells (stained with CMFDA, green) were mixed with normal MDCK cells. **(e)** Immunofluorescence images of keratin5+8 (red) in the mix culture of normal and RasV12-transformed cells. RasV12-MDCK cells (stained with CMFDA, green) were mixed with normal MDCK cells. Arrows indicate vimentin **(d)** or keratin5+8 **(e)** accumulation in normal MDCK cells at the interface with RasV12-MDCK cells. Scale bars, 10 μ m **(d,e)**.

Figure 6 | Filamin acts as a key mediator in the interaction between normal and transformed epithelial cells. **(a)** Immunofluorescence images of filamin (green) and vimentin (red). Asterisks indicate the Src-transformed cell surrounded by normal cells. Arrows indicate colocalisation of filamin and vimentin in the neighbouring normal cells at the interface with the Src-transformed cell. **(b)** Quantification of vimentin accumulation in filamin A-knockdown cells at the interface with Src-transformed cells. Representative images were shown on the right. Values are expressed as a ratio relative to tet (-). Data are mean $\pm$ s.e. from three independent experiments. * $P=0.0020$ (Student's t -test). **(c)** Quantification of filamin accumulation in vimentin-knockdown cells at the interface with Src-transformed cells. Data are mean $\pm$ s.e. from three independent experiments. Values are expressed as a ratio relative to tet (-). **(d)** Immunofluorescence images of PKC ϵ (red) in the mix culture of MDCK pTR-filamin shRNA1 and ts-Src MDCK cells (green). Filamin shRNA1 expression was not induced (upper panels) or

induced by tetracycline (lower panels). Arrows indicate the accumulation of PKC ϵ in the surrounding cells at the interface with ts-Src MDCK cells. (e) Immunofluorescence images of phosphorylated vimentin (p-Ser38) in the mix culture of MDCK GFP-vimentin and ts-Src MDCK cells. Arrows indicate colocalisation of phosphorylated-vimentin (white) and accumulated GFP-vimentin at the interface with Src-transformed cells (red). v-Src activation was induced at 35°C (upper panels) or not induced at 40.5°C (lower panels). Scale bars, 10 μ m (a,b,d,e). (f) Effect of Bisindolylmaleimide (BIM) -I on apical extrusion of Src-transformed cells. Data are mean $\pm$ s.e. from three independent experiments. * $P=0.0078$ (Student's t -test). (g) Effect of BIM-I on vimentin accumulation at the interface with Src-transformed cells. Data are mean $\pm$ s.e. from two independent experiments. Values are expressed as a ratio relative to DMSO. * $P=0.0037$ (Student's t -test). (h) Effect of BIM-I on filamin accumulation in the surrounding normal cells at the interface with Src-transformed cells. Data are mean $\pm$ s.e. from two independent experiments.

Figure 7 | The Rho-Rho kinase pathway in the surrounding normal cells is involved in filamin accumulation at the boundary with transformed cells. (a) Effect of Y27632 on filamin accumulation at the interface with RasV12-MDCK cells. Data are mean $\pm$ s.e. from two independent experiments. * $P=0.044$ (Student's t -test). (b) Effect of Y27632 on filamin accumulation at the interface with ts-Src MDCK cells. Data are mean $\pm$ s.e. from three independent experiments. Values are expressed as a ratio relative to DMSO. * $P=0.0045$ (Student's t -test). (c,d) Effect of overexpression of RhoGAP in the surrounding cells on apical extrusion of RasV12-MDCK cells (c) or filamin accumulation

at the interface with RasV12-MDCK cells **(d)**. Data are mean $\pm$ s.e. from two independent experiments. Values are expressed as a ratio relative to MDCK:Ras=50:1 **(d)**. $*P=0.011$ **(c)**, $*P=2.8 \times 10^{-4}$ **(d)** (Student's *t*-test). **(e,f)** Effect of overexpression of RhoGAP in the surrounding cells on apical extrusion of ts-Src MDCK cells **(e)** or filamin accumulation at the interface with ts-Src MDCK cells **(f)**. Data are mean $\pm$ s.e. from three independent experiments. Values are expressed as a ratio relative to tet (-) **(f)**. $*P=0.041$ **(e)**, $*P=2.0 \times 10^{-4}$ **(f)** (Student's *t*-test). **(g,h)** Effect of overexpression of a dominant negative mutant of Rho kinase in the surrounding cells on apical extrusion of RasV12-MDCK cells **(g)** or filamin accumulation at the interface with RasV12-MDCK cells **(h)**. Data are mean $\pm$ s.e. from three **(g)** or two **(h)** independent experiments. Values are expressed as a ratio relative to MDCK:Ras=50:1 **(h)**. $*P=0.0040$ **(g)**, $*P=0.033$ **(h)** (Student's *t*-test). **(i,j)** Effect of overexpression of a dominant negative mutant of Rho kinase in the surrounding cells on apical extrusion of ts-Src MDCK cells **(i)** or filamin accumulation at the interface with ts-Src MDCK cells **(j)**. Data are mean $\pm$ s.e. from five **(i)** or three **(j)** independent experiments. Values are expressed as a ratio relative to MDCK:Src=50:1 **(j)**. $*P=0.040$ **(i)**, $*P=0.011$ **(j)** (Student's *t*-test).

Figure 8 | Myosin-II activity in transformed cells regulates filamin accumulation in the surrounding normal cells. **(a)** Effect of blebbistatin on filamin accumulation in the surrounding normal cells at the interface with Src-transformed cells. Data are mean $\pm$ s.e. from three independent experiments. $*P=0.024$ (Student's *t*-test). **(b)** Effect of MLC-AA expression in v-Src-expressing cells on filamin accumulation in the surrounding normal cells. v-Src and/or mCherry-tagged MLC-AA were transiently transfected in MDCK

cells. v-Src-transfected cells were identified by immunofluorescence using anti-pY418-Src antibody. Asterisks indicate v-Src-expressing cells. AA; MLC-AA. Data are mean $\pm$ s.e. from three independent experiments. $*P=0.0028$ (Student's *t*-test). (c) Establishment of MDCK-pTR GFP-RasV12 cells stably expressing mCherry-MLC-AA. The expression of GFP-RasV12 was not induced or induced for 24 h by tetracycline, followed by western blotting with the indicated antibodies. (d) Effect of MLC-AA-coexpression in RasV12-transformed cells on filamin accumulation in the surrounding normal cells. Cells were stained with anti-filamin antibody (blue). White and red asterisks indicate RasV12- and RasV12+MLC-AA-expressing cells, respectively. Data are mean $\pm$ s.e. from three independent experiments. Values are expressed as a ratio relative to RasV12-expressing cells. $*P=0.017$ (Student's *t*-test). Representative images were shown on the right (a,b,d). Scale bars, 10 μ m (a,b,d).

Figure 9 | Molecular mechanisms of EDAC (Epithelial Defence Against Cancer). A schematic model of molecular mechanisms for the defensive force of the neighbouring normal cells against transformed cells. When transformed cells are surrounded by normal epithelial cells, myosin-II activity is up-regulated in the transformed cells, which in turn induces filamin (FLN) accumulation in the normal cells at the interface in a Rho/Rho kinase-dependent manner. Accumulated filamin regulates dynamic movement of vimentin (vim) through its phosphorylation via PKC ϵ . Holding arm-like vimentin filaments in normal cells generate contractile forces at the interface that prevent the neighbouring transformed cells from forming basal extensions, thereby promoting their apical extrusion from the epithelial monolayer.

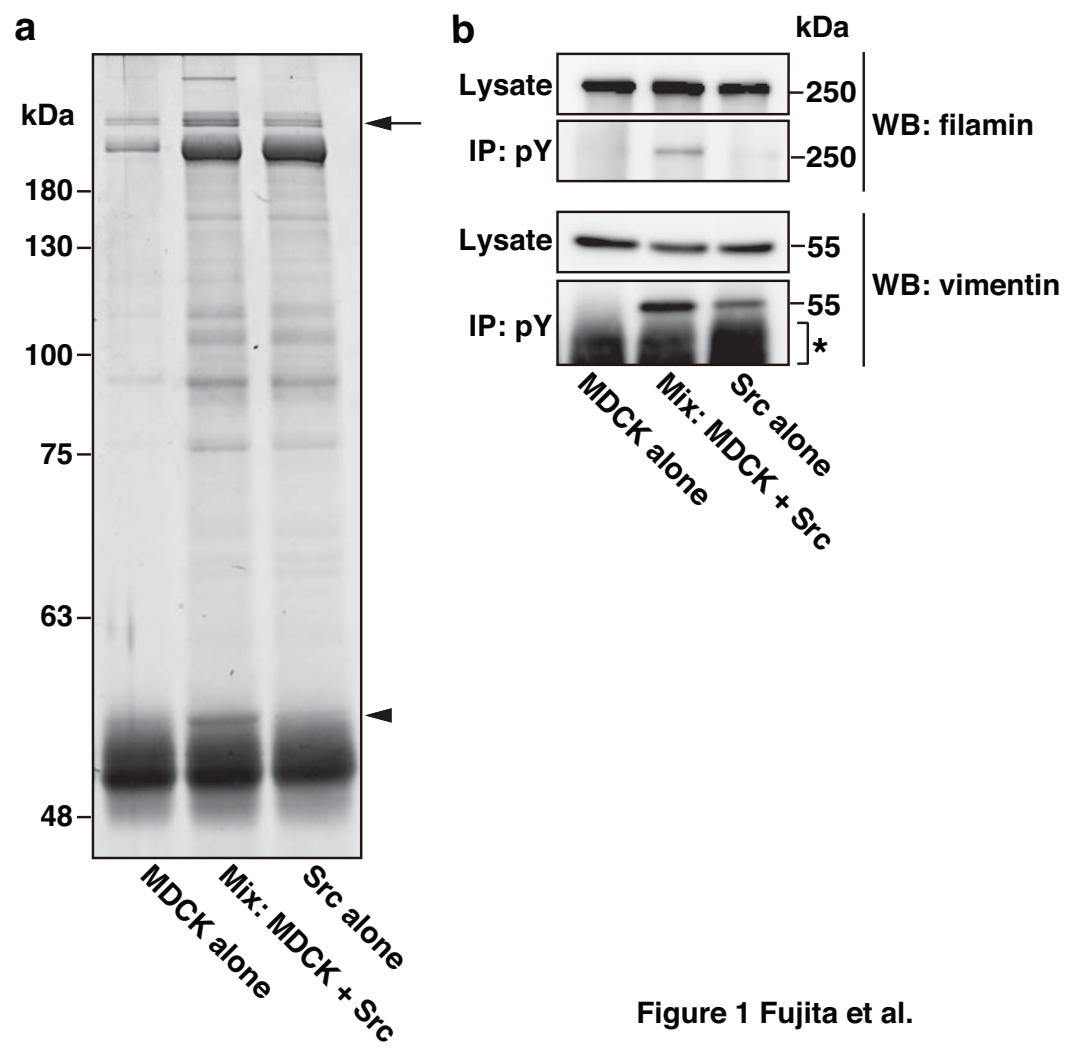


Figure 1 Fujita et al.

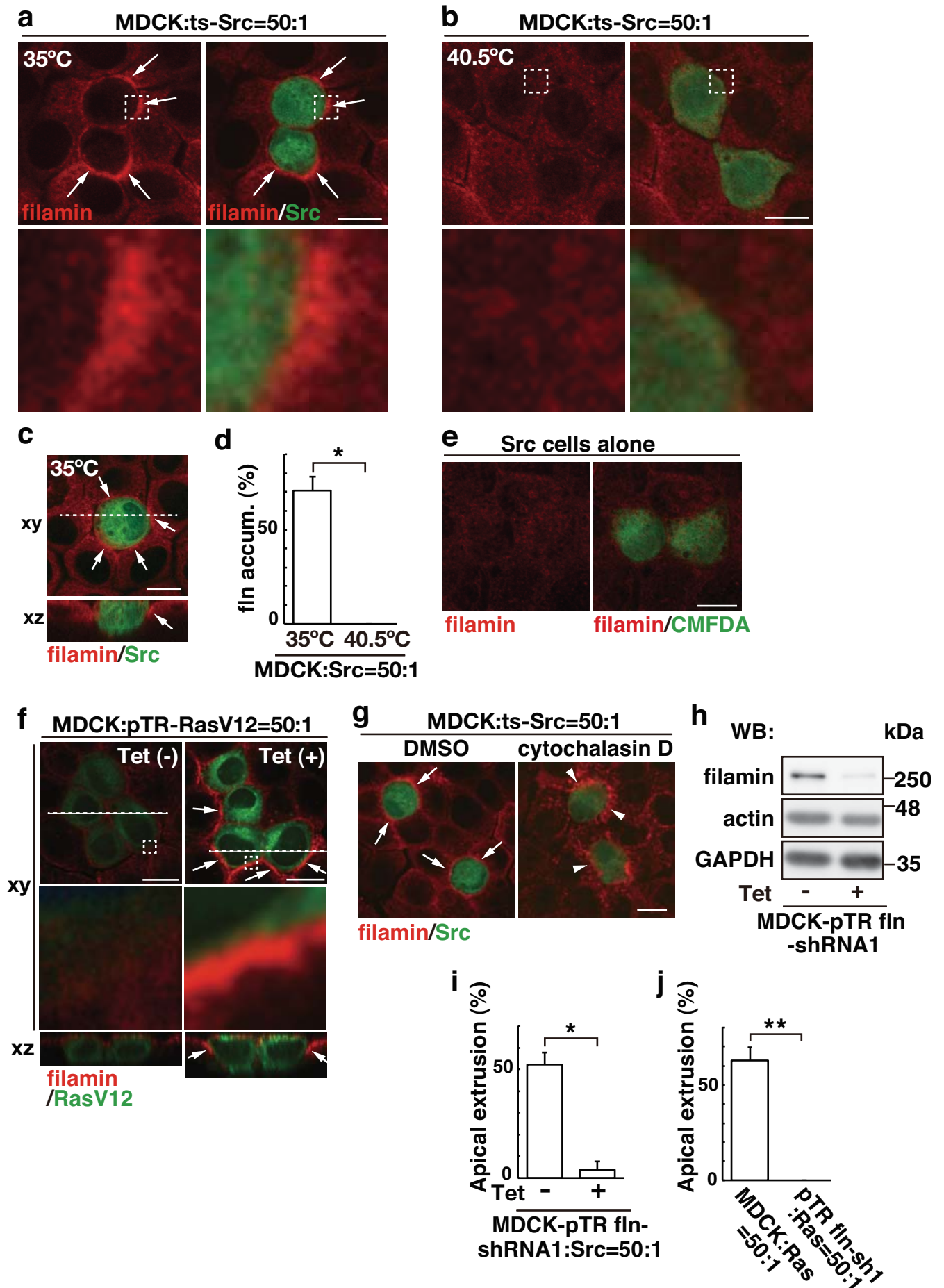
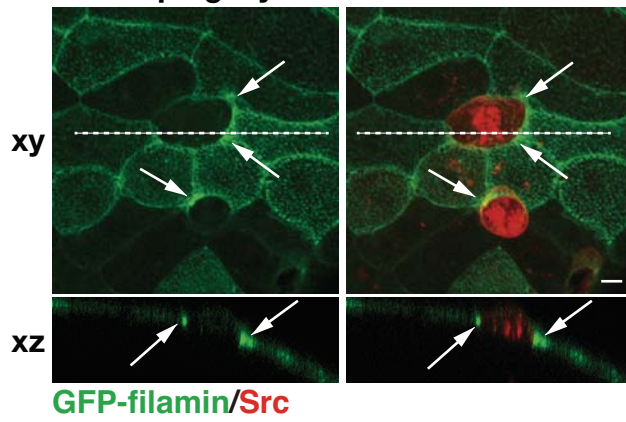
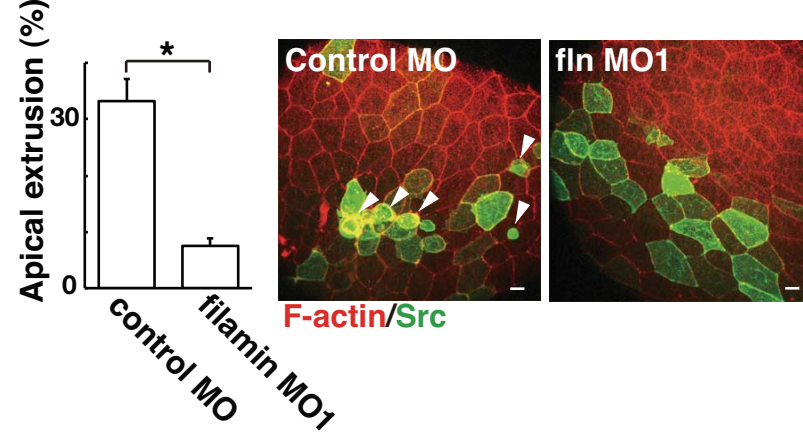


Figure 2 Fujita et al.

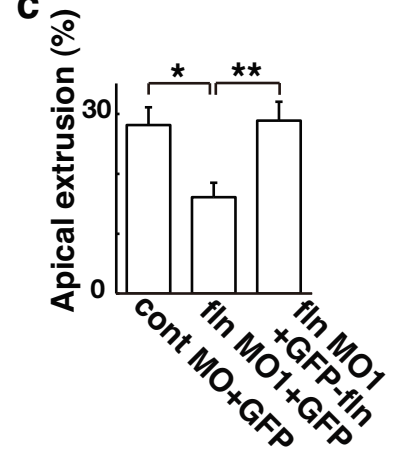


Figure 3 Fujita et al.

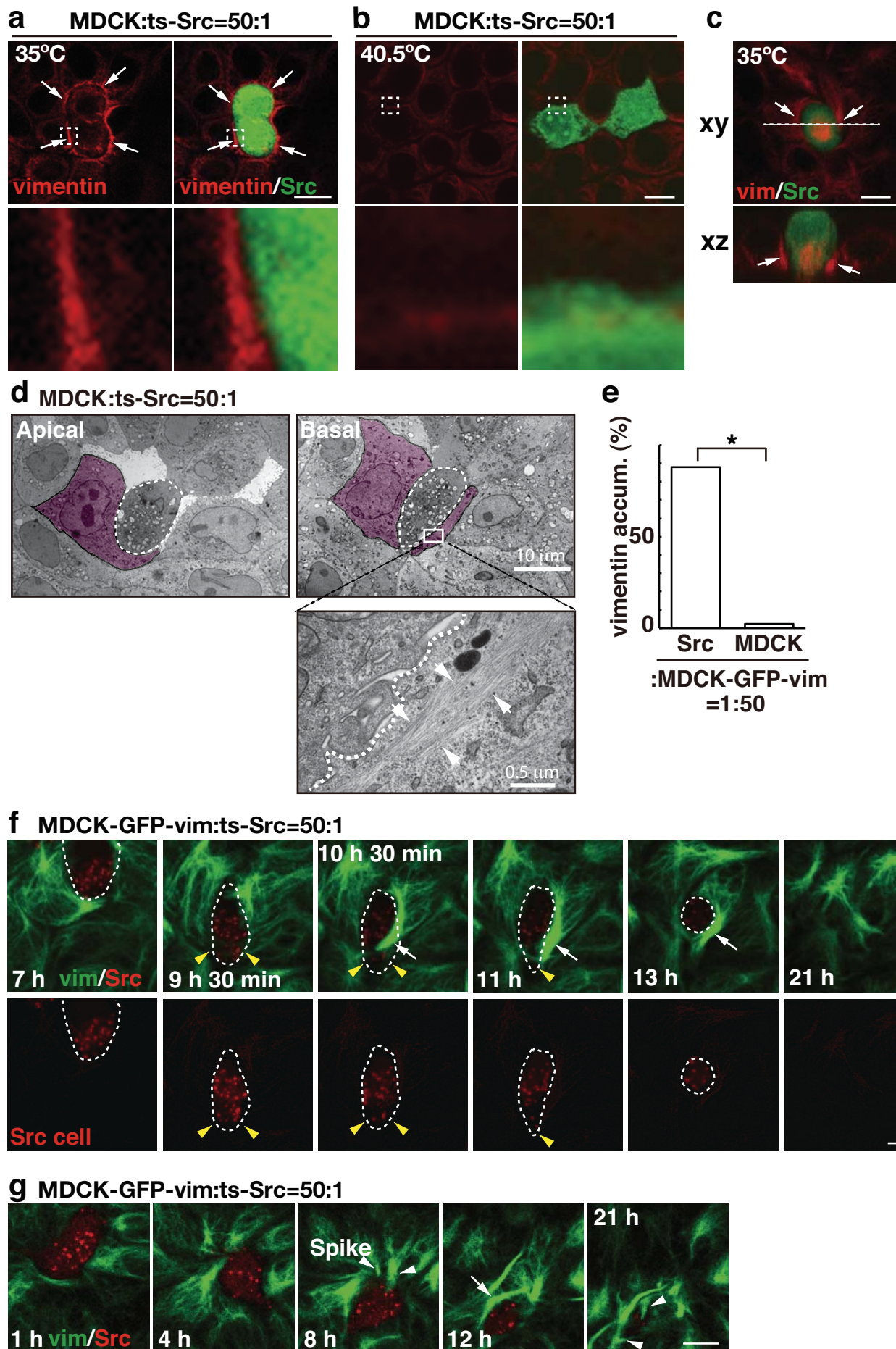


Figure 4 Fujita et al.

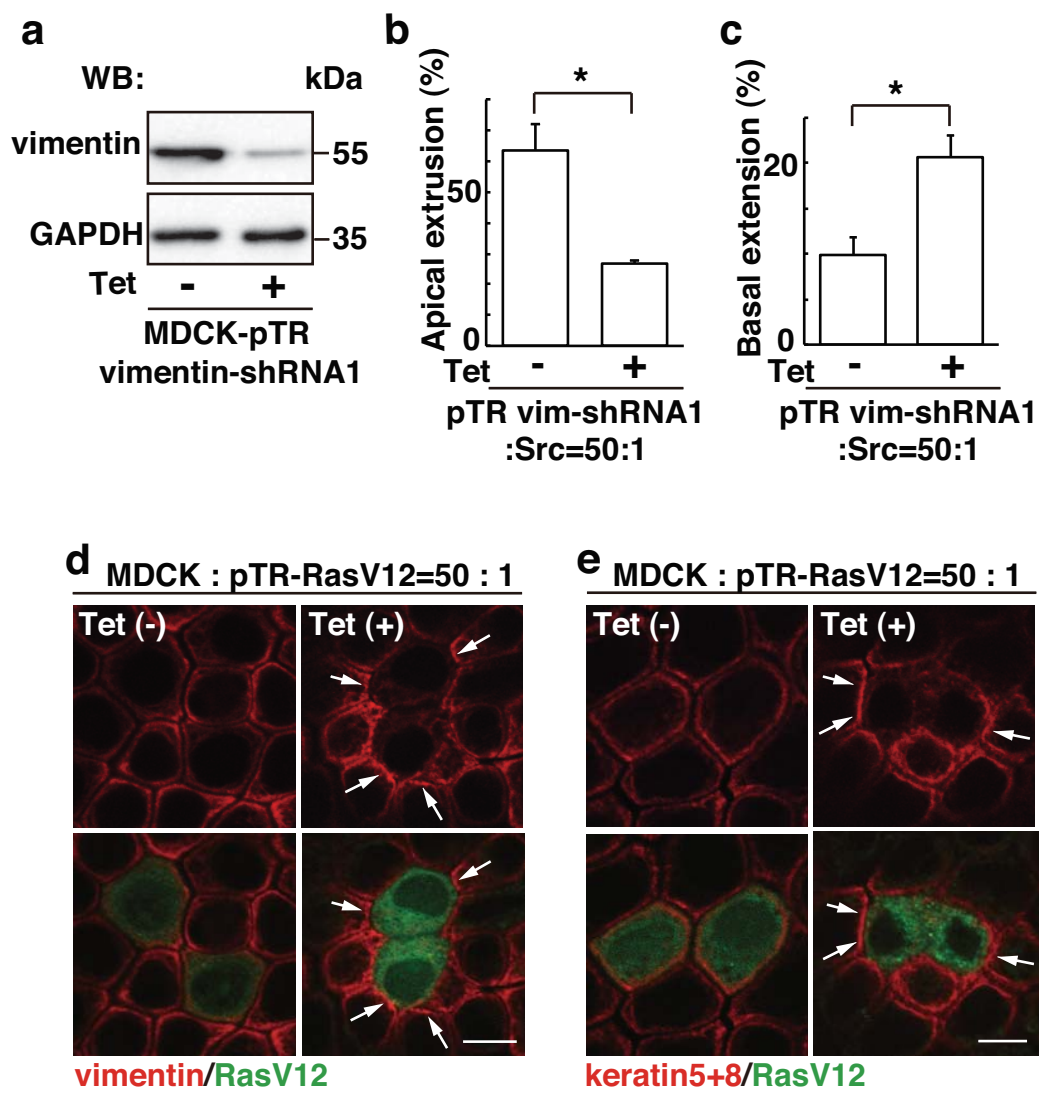


Figure 5 Fujita et al.

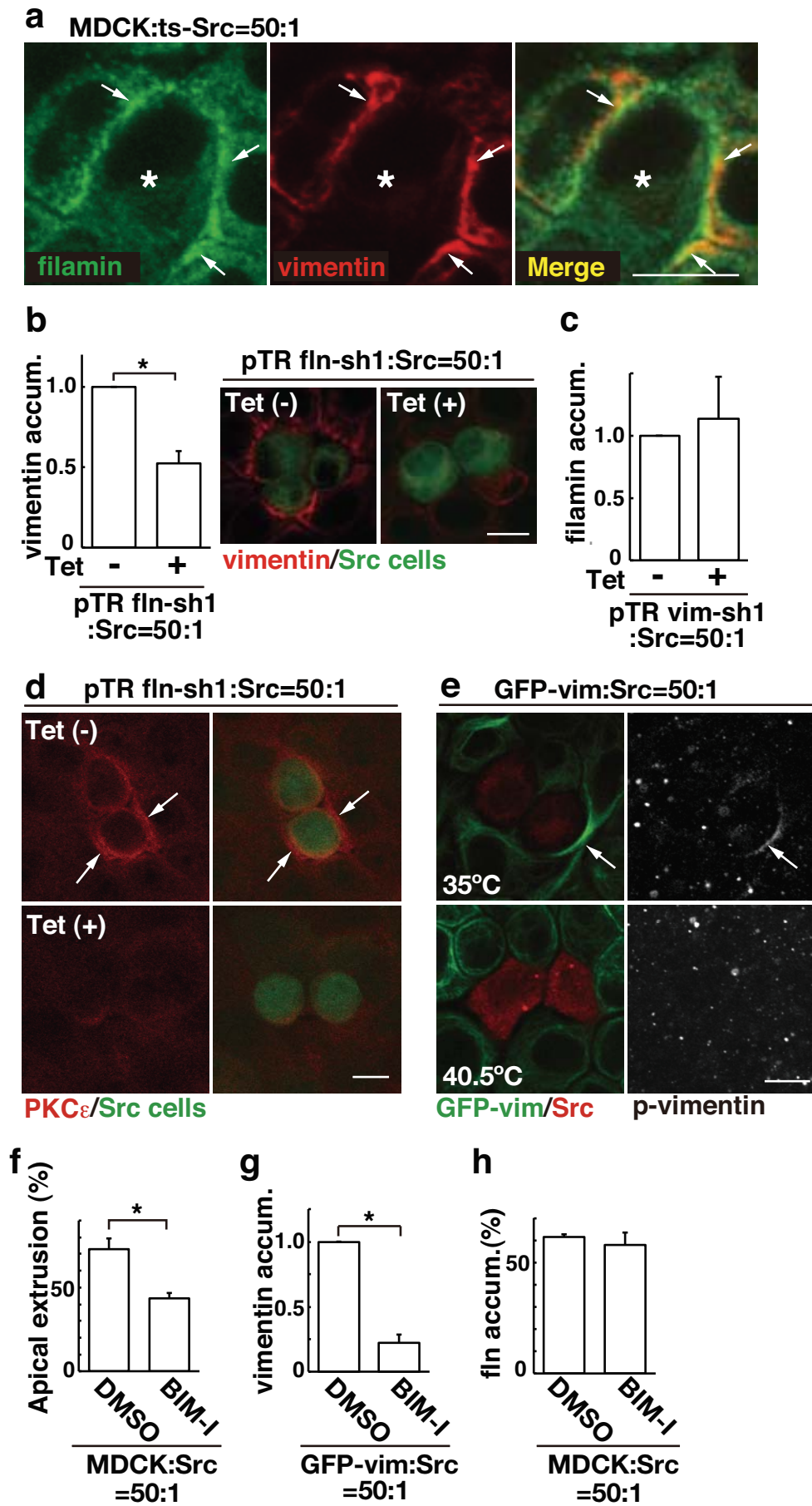


Figure 6 Fujita et al

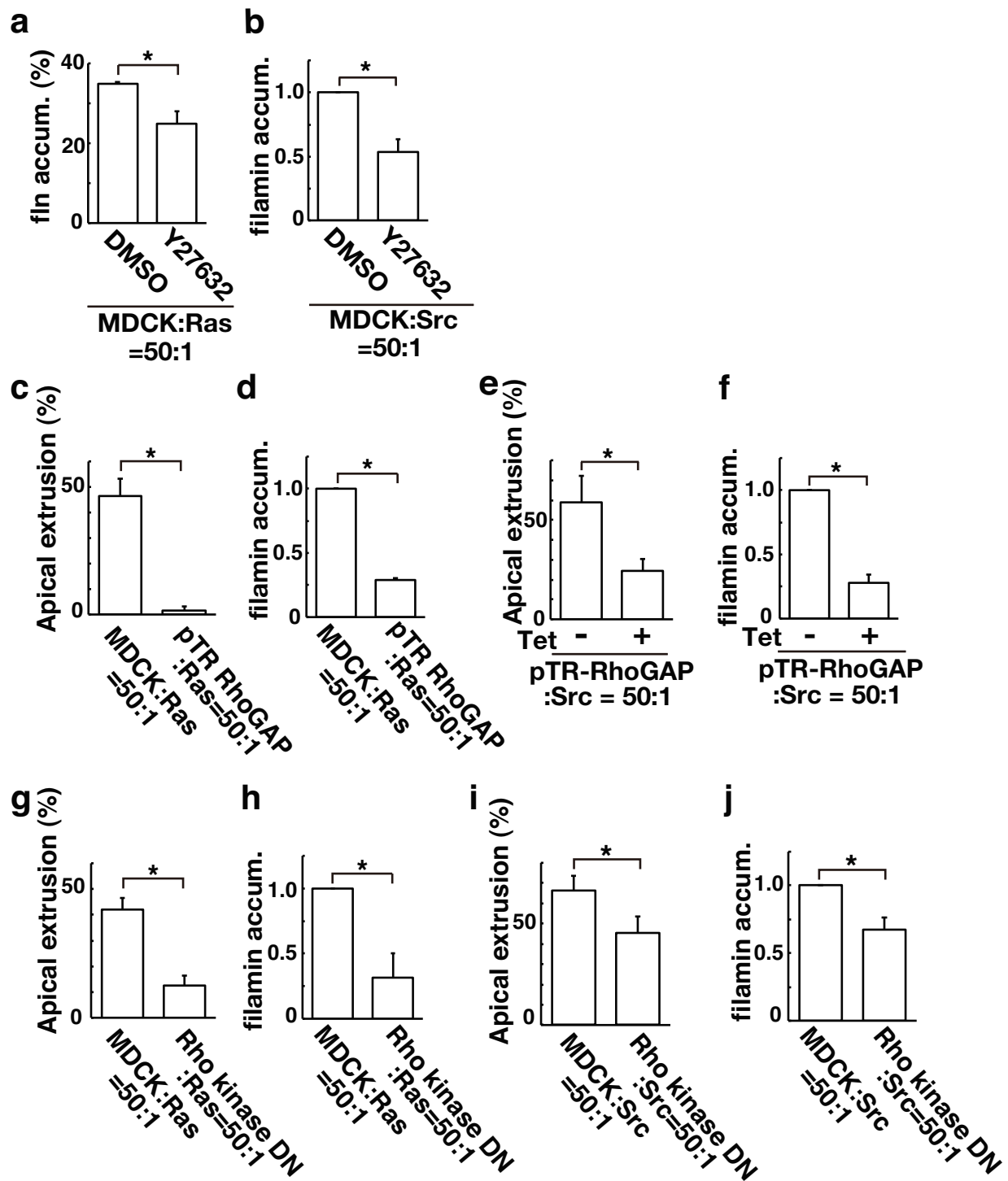


Figure 7 Fujita et al

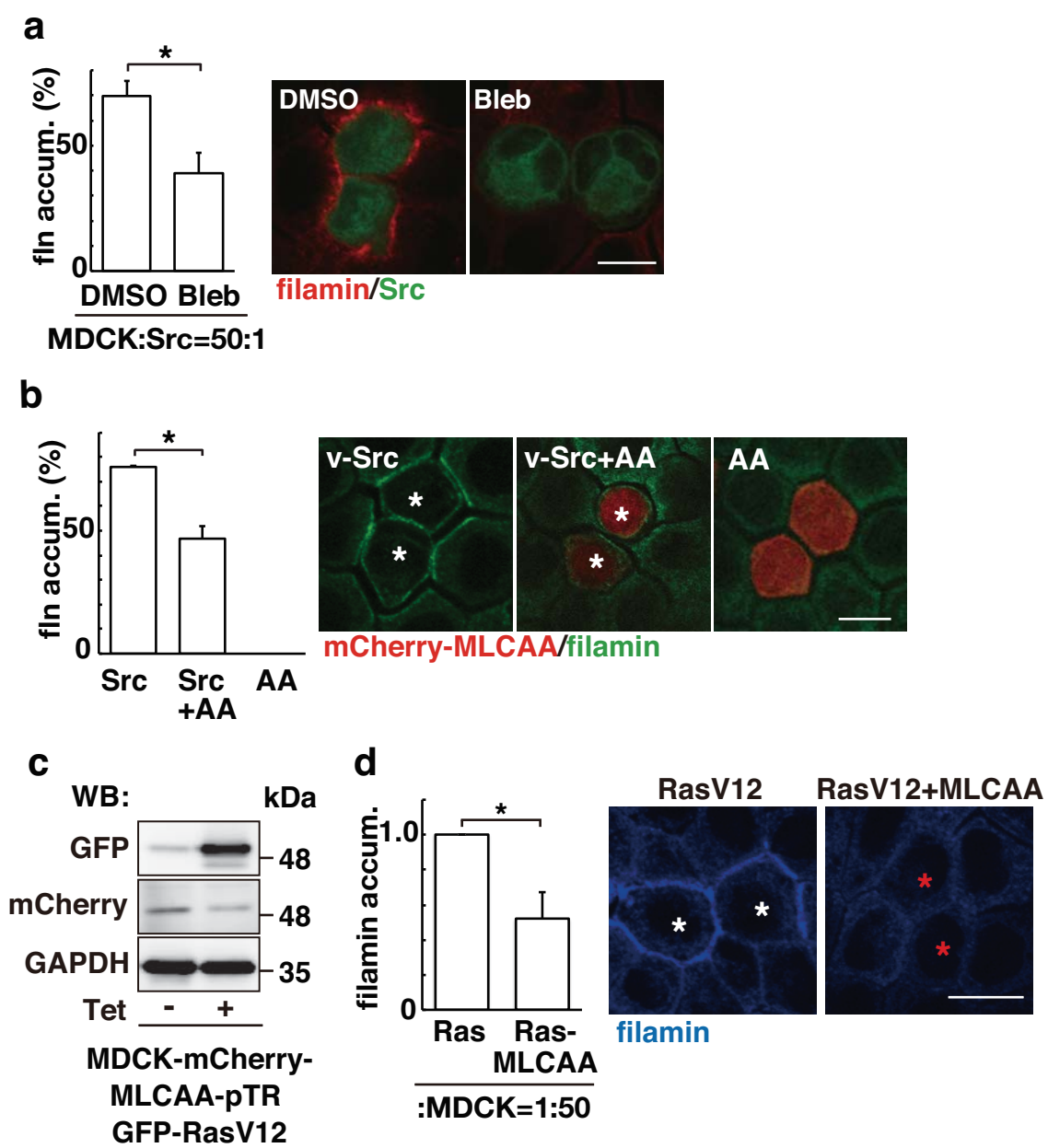


Figure 8 Fujita et al

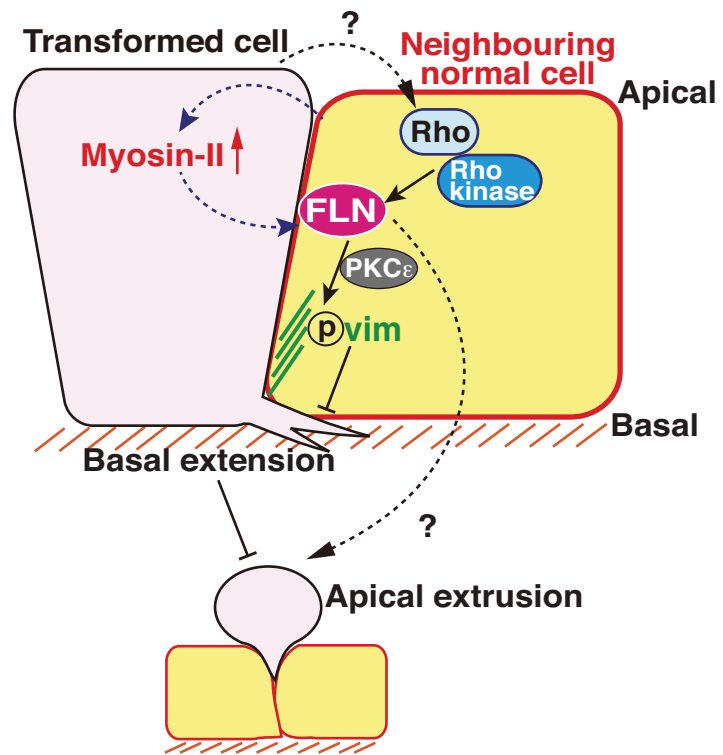
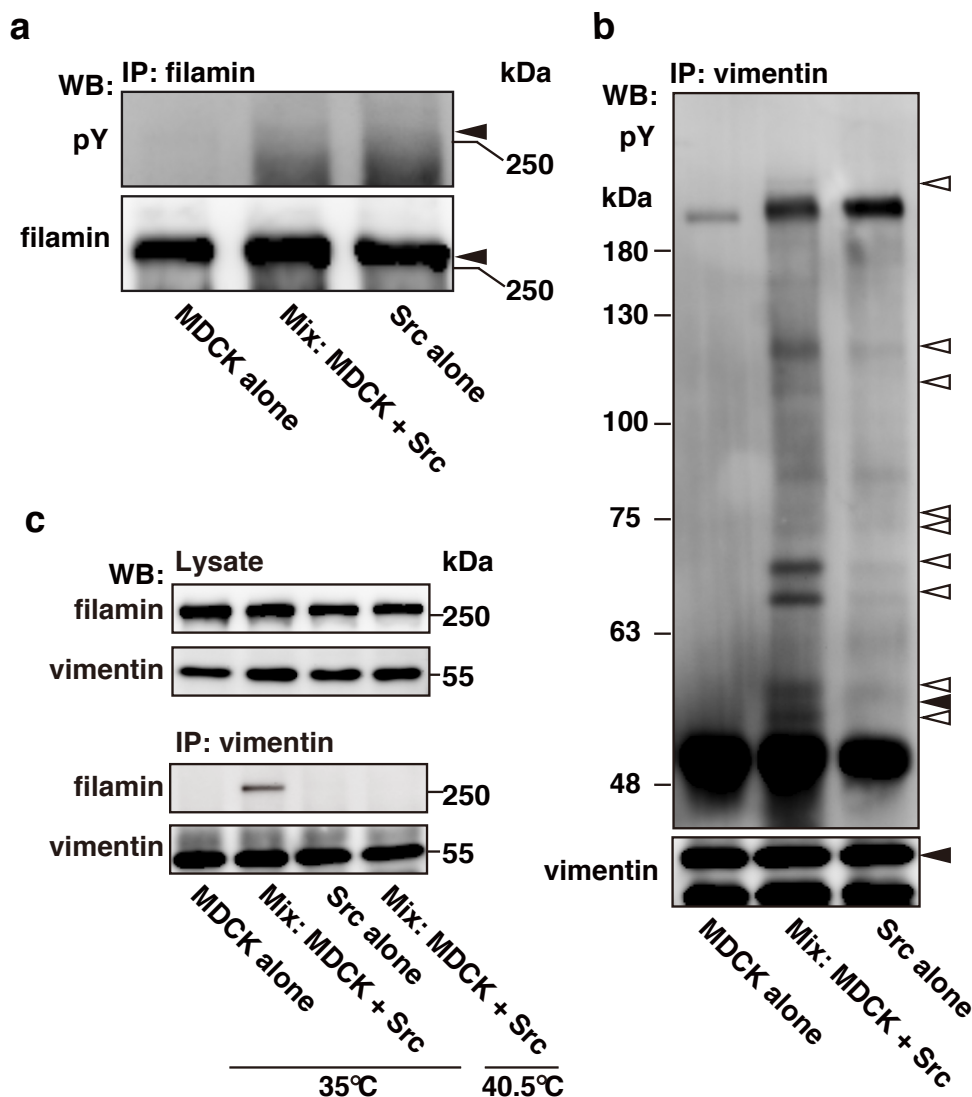


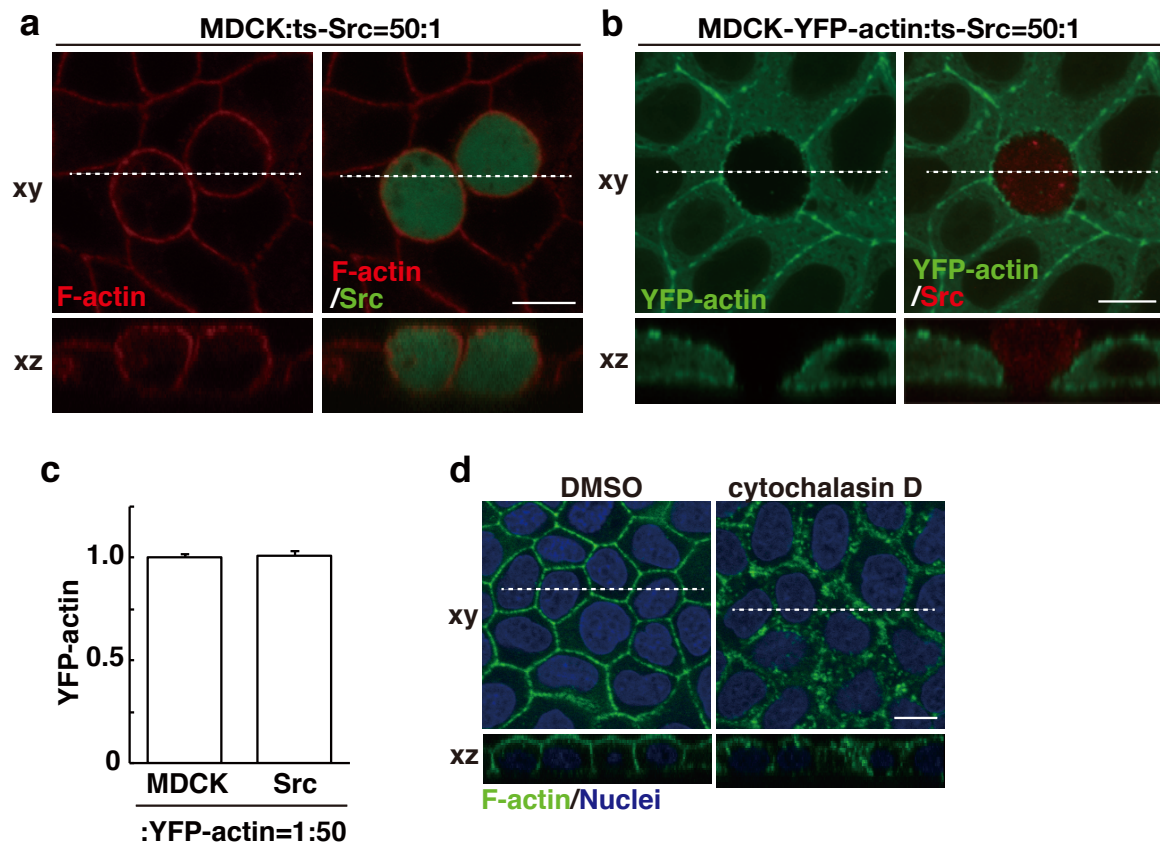
Figure 9 Fujita et al

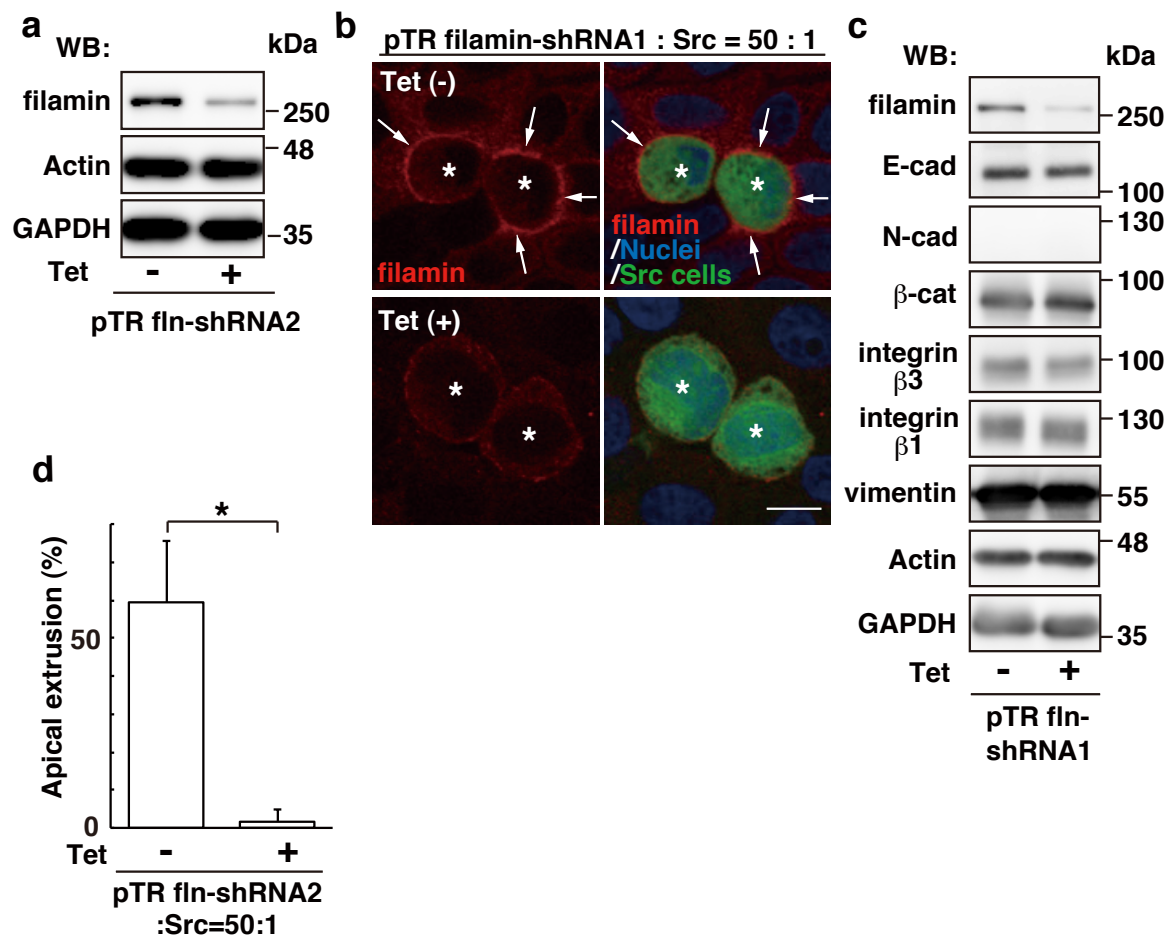


Supplementary Figure 1 Vimentin binds to multiple tyrosine phosphorylated proteins when normal and Src-transformed cells interact with each other.

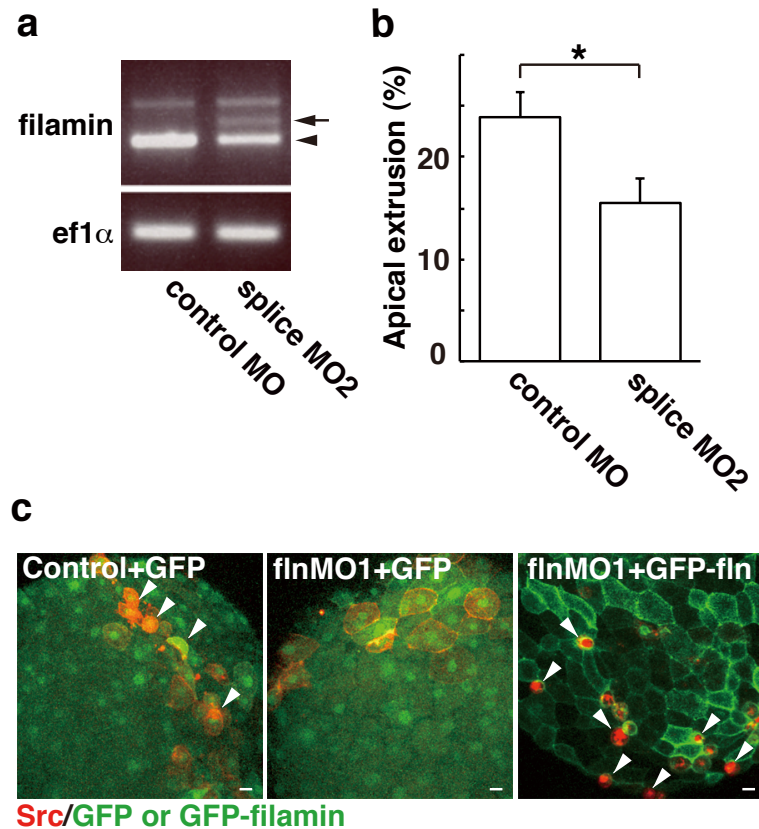
Filamin (a) or vimentin (b) is not tyrosine phosphorylated; instead multiple tyrosine phosphorylated proteins bind to vimentin under the mix culture condition of normal and Src-transformed cells. Black arrowheads indicate the position of filamin (a) or vimentin (b). White arrowheads indicate the bands for vimentin-binding tyrosine phosphorylated proteins in the mix culture. It should be noted that we have been unable to identify these tyrosine phosphorylated proteins because of their low quantity. (c) Specific interaction between filamin and vimentin under the mix culture condition of normal and Src-transformed cells. Cells were cultured at 35°C as the permissive temperature or at 40.5°C as the non-permissive temperature. (a-c) Cells were cultured under three different conditions: i) normal MDCK cells alone, ii) 1:1 mix culture of normal and Src-transformed MDCK cells, and iii) Src-transformed MDCK cells alone. The cell lysates were used for immunoprecipitation with anti-filamin (a) or anti-vimentin (b,c) antibody, followed by western blotting with the indicated antibodies.



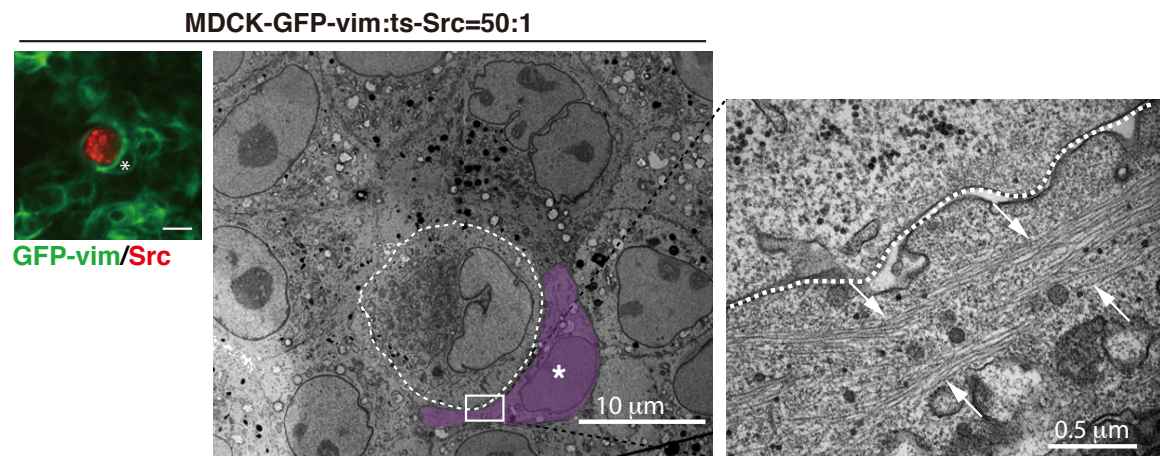
Supplementary Figure 2 F-actin is not specifically accumulated in the surrounding normal cells at the interface with Src-transformed cells. (a) F-actin is not specifically accumulated at the interface between normal and Src-transformed cells. ts-Src MDCK cells stained with CMFDA (green) were mixed with normal MDCK cells. Cells were stained with Alexa-Fluor-647-phalloidin (red). (b) YFP-actin in the surrounding normal cells is not specifically accumulated at the interface with Src-transformed cells. ts-Src MDCK cells stained with CMTX (red) were mixed with MDCK cells stably expressing YFP-actin (green). (c) Quantification of the fluorescence intensity of YFP-actin at the interface with Src-transformed cells. Data are mean $\pm$ s.e. from three independent experiments. Values are expressed as a ratio relative to MDCK:YFP-actin = 1:50. (d) F-actin structures are disrupted by cytochalasin D. White dashed lines in xy panels denote the cross-sections represented in xz panels (a,b,d). Scale bars, 10 μ m (a,b,d).



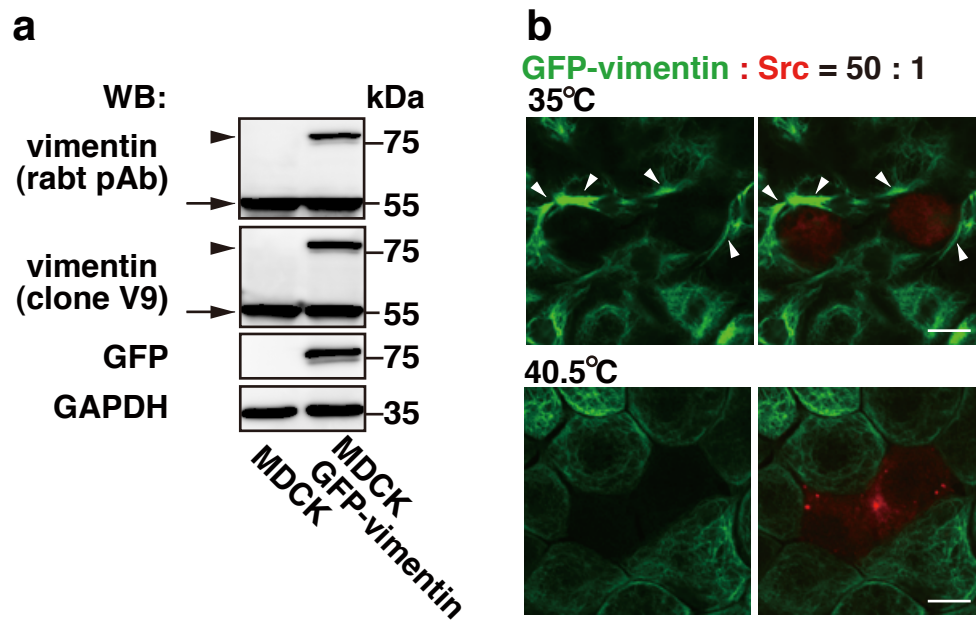
Supplementary Figure 3 Effect of knockdown of filamin A in the surrounding cells on apical extrusion of Src-transformed cells. (a) Establishment of MDCK cells stably expressing filamin A shRNA2 in a tetracycline-inducible manner. Knockdown was induced for 72 h with tetracycline treatment, followed by western blotting with the indicated antibodies. (b) The absence of filamin accumulation in filamin A-knockdown cells at the interface with Src-transformed cells. ts-Src MDCK cells stained with CMFDA (green) were mixed with MDCK-pTR filamin A-shRNA1 cells, and v-Src activation was induced for 12 h at 35°C. 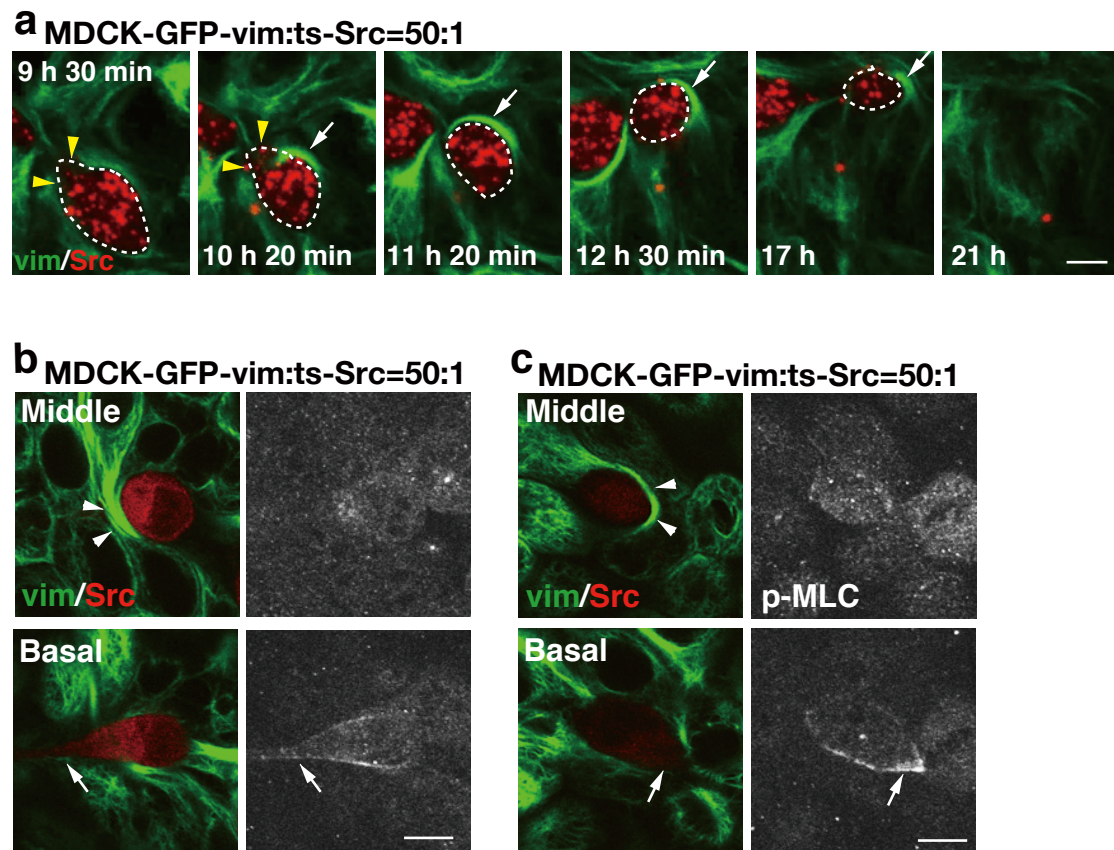
Supplementary Figure 4 Filamin knockdown significantly suppresses apical extrusion of v-Src-expressing cells in the EVL epithelium of zebrafish embryos. (a) RT-PCR detection of filamin transcripts at 11 hpf in control MO- and filamin splice MO2-injected zebrafish embryos. The arrow and arrowhead indicate mis-spliced filamin and wild-type filamin, respectively. Ef1 α was used as a control. 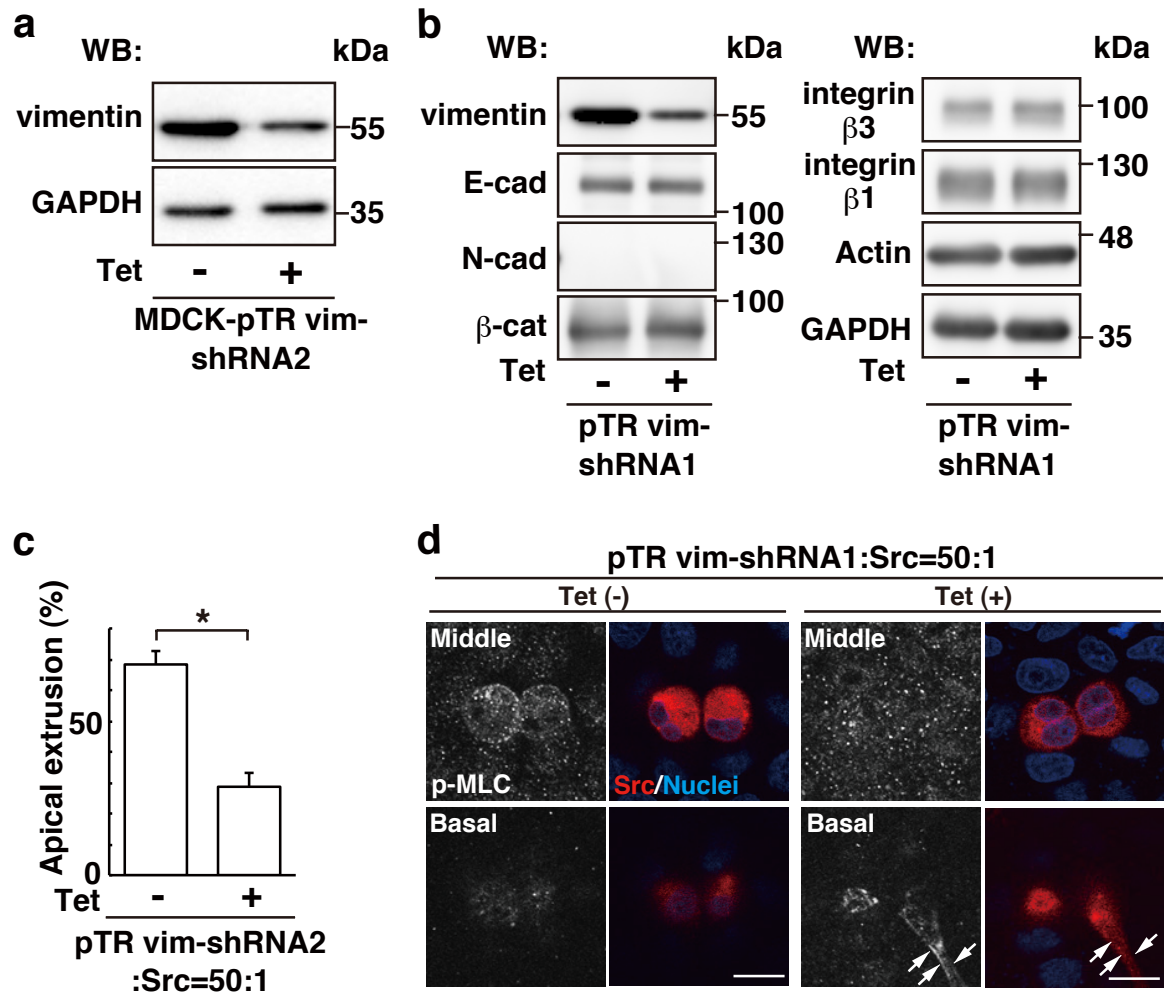
Supplementary Figure 5 Electron microscopic analyses demonstrate that intermediate filament-like structures are accumulated in the holding arm-like extension from the neighbouring normal cell. 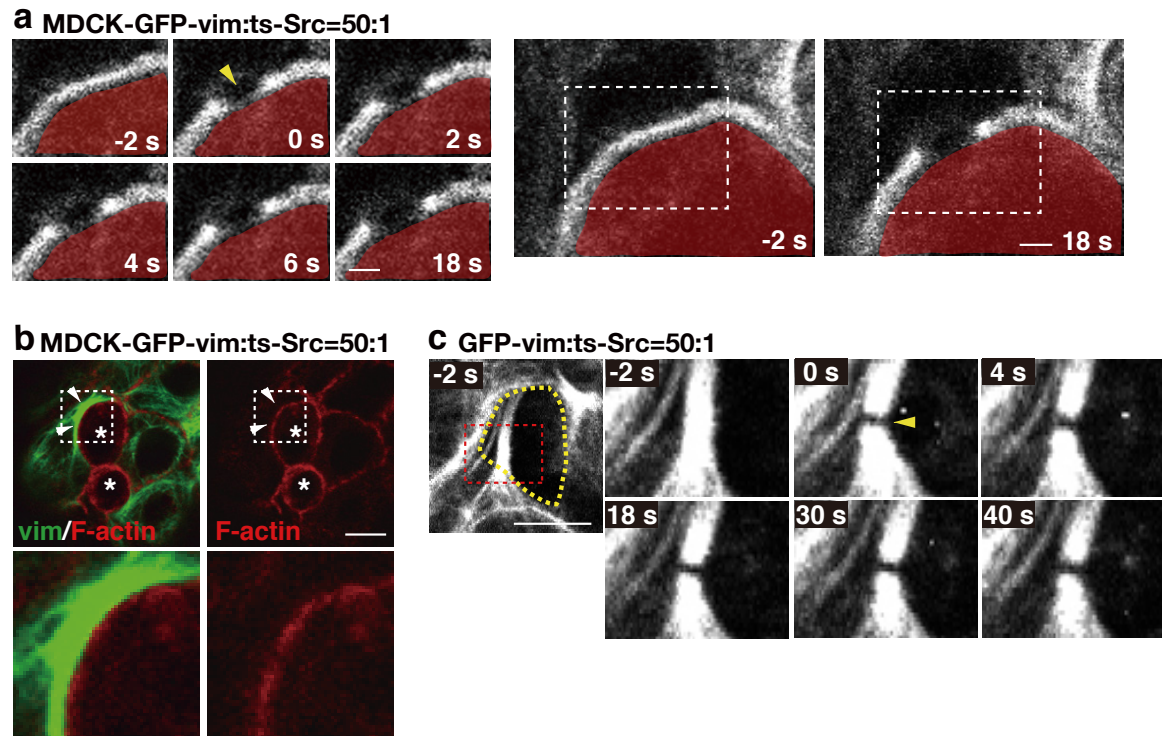
Supplementary Figure 6 GFP-vimentin is accumulated in the surrounding cells at the interface with Src-transformed cells. (a) Establishment of MDCK cells stably expressing GFP-vimentin. Arrowheads and arrows indicate the band for GFP-vimentin and endogenous vimentin, respectively. Supplementary Figure 7 Analyses of vimentin-filaments at the interface with Src-transformed cells. Images are extracted from representative time-lapse analyses. ts-Src MDCK cells (stained with CMTPX, red) were mixed with MDCK GFP-vimentin cells. White arrows indicate “holding arm-like protrusions”. Yellow arrowheads indicate basal extension of a Src-transformed cell. White dashed lines delineate a Src-transformed cell. The presented time in each image indicates the duration of v-Src activation. (b,c) Holding arm-like protrusions of normal cells at the interface where ts-Src MDCK cells protrude basally. ts-Src MDCK cells (stained with CMTPX, red) were mixed with MDCK GFP-vimentin cells and immuno-stained with p-MLC. Supplementary Figure 8 Effect of knockdown of vimentin in the surrounding cells on apical extrusion of Src-transformed cells. (a) Establishment of MDCK cells stably expressing vimentin shRNA2 in a tetracycline-inducible manner. Knockdown was not induced or induced for 72 h with tetracycline treatment, followed by western blotting with the indicated antibodies. (b) Effect of knockdown of vimentin on the expression of various adhesion molecules. Knockdown was not induced or induced for 72 h with tetracycline treatment, followed by western blotting with the indicated antibodies. (c) Effect of knockdown of vimentin using vimentin shRNA2 in the surrounding cells on apical extrusion of ts-Src MDCK cells. Data are mean $\pm$ s.e. from three independent experiments. $*P=0.0017$ (Student's *t*-test). (d) Representative images for Fig. 5c. Src-transformed cells stained with CMTPIX (red) were mixed with MDCK-pTR vimentin-shRNA1 cells, and v-Src activation was induced for 12 h at 35°C. MDCK-pTR vimentin-shRNA1 cells were incubated without (left panels) or with (right panels) tetracycline for 72 h prior to v-Src activation. 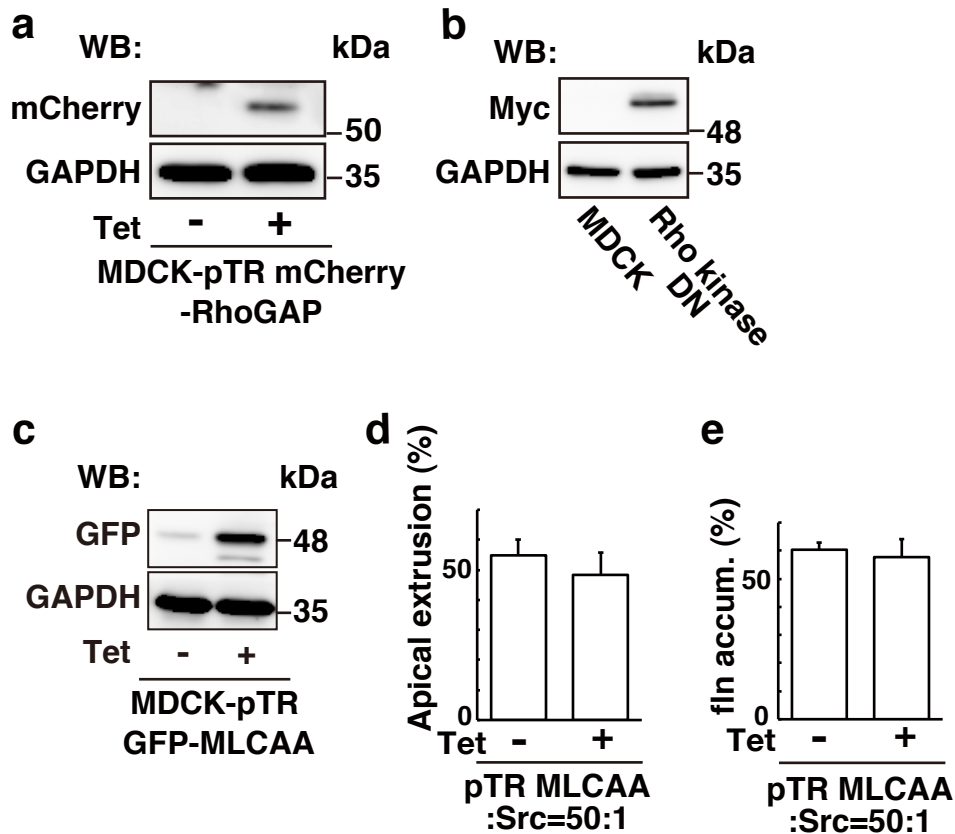
Supplementary Figure 9 Holding arm-like vimentin filaments generate contractile forces. (a) Representative images of laser irradiated holding arm-like GFP-vimentin filaments at the interface with a Src-transformed cell. The mean $\pm$ s.d. of recoil velocity of vimentin filaments is $0.021 \pm 0.011 \mu\text{m/s}$. 0 s: time of laser ablation. An arrowhead indicates the ablated region. GFP-vimentin is shown in white. Red shaded areas mark a ts-Src MDCK cell. Note that laser ablation was performed onto small areas by point-scan mode and that instant recoiling of vimentin filament ends already appears in the image at 0 s (see Supplementary Movie 3)(For reference, see the image at 0 s in Supplementary Fig. 9c). After the instant recoiling, more gradual recoiling was observed for 10 seconds. The larger cell images are shown in the right panels, demonstrating the minimal cell shape change by laser ablation. These data (a,b) indicate that recoiling of the ends of ablated vimentin filaments does not involve the tensile forces generated by co-existing actomyosin filaments. (c) Representative images of the laser-irradiated vimentin-rich “spiky protrusion” at the interface with Src-transformed cells. GFP-vimentin is shown in white. 0 s: time of laser ablation. Yellow dashed lines delineate a ts-Src MDCK cell. The area in the red box is shown at higher magnification in the right panels. The arrowhead indicates the ablated region. Scale bars, 1 μm (a), 10 μm (b), 5 μm (c).

The ends of laser ablated spiky protrusions are not recoiled, indicating that spiky protrusions do not generate tensile forces. In addition, when the laser was irradiated onto vimentin filaments in normal cells that did not interact with transformed cells,

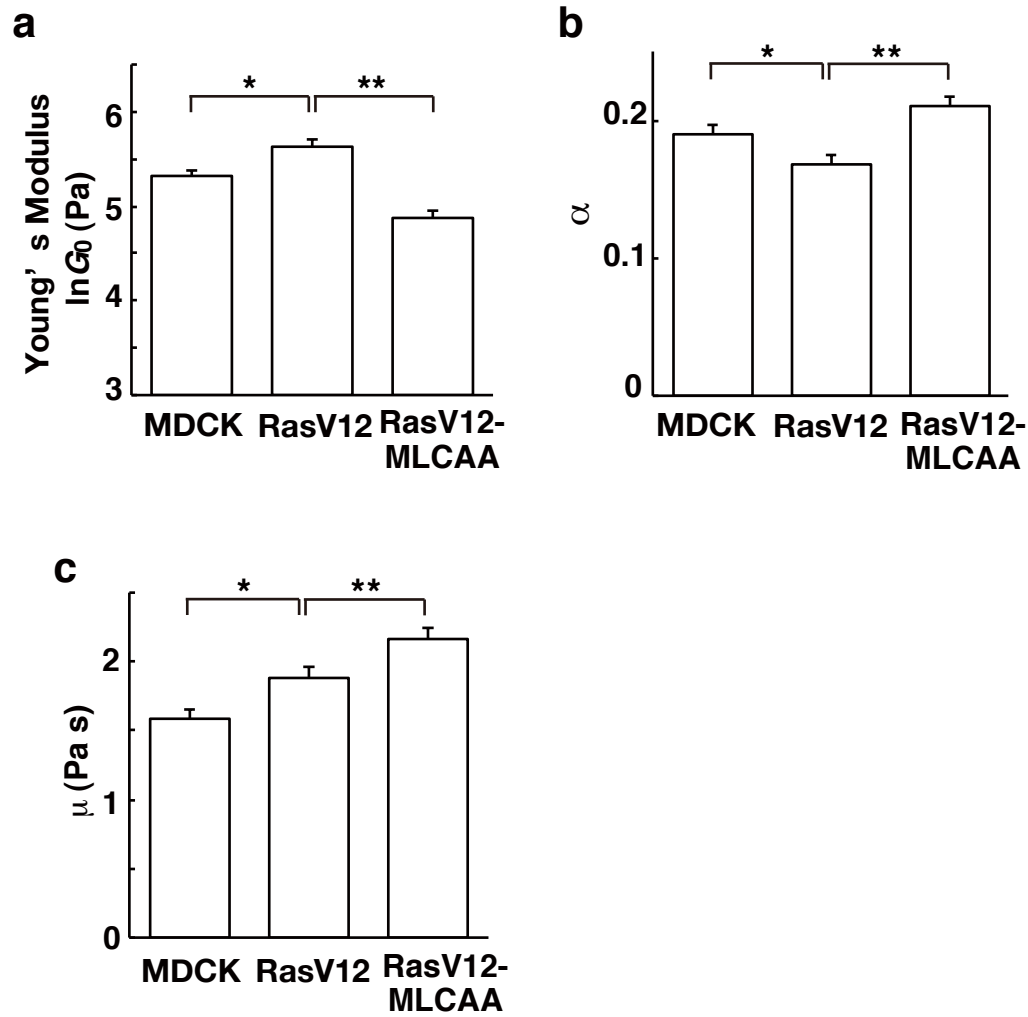
the filamentous structures were massively disrupted, suggesting that ordinary vimentin filaments (and their associated environment) are physically more fragile than holding arm-like vimentin filaments.

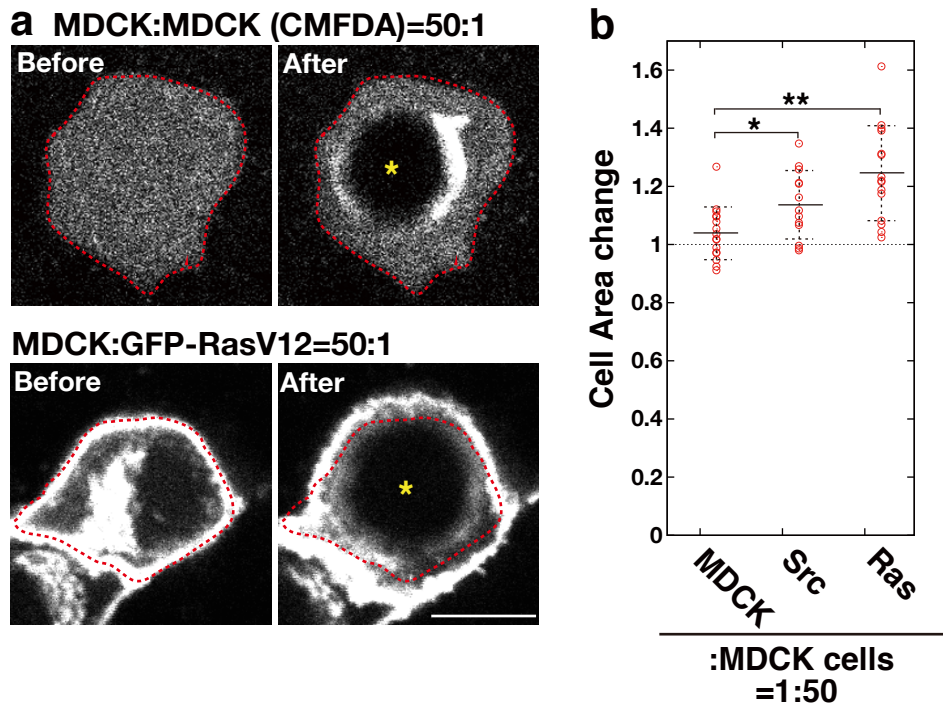
It was reported that apoptotic cells are apically extruded by the tensile forces generated by actomyosin cytoskeletons in the surrounding epithelial cells (Rosenblatt et al., 2001 Curr. Biol.). In contrast, we show that F-actin is not specifically accumulated around the apically extruding transformed cells (Supplementary Fig. 2a-c). Instead, intermediate filaments are accumulated in normal cells at the interface with transformed cells. Laser ablation experiments reveal that holding arm-like vimentin filaments generate contractile forces (Supplementary Fig. 9a). We present data suggesting that vimentin filaments prevent the neighboring transformed cells from forming basal extensions by providing tensile forces at the interface. In addition, at the final stage of apical extrusion, vimentin filaments are densely accumulated around transformed cells as if squeezing them out (Supplementary Movie 1); thus it is possible that vimentin-generated contractile forces are also involved in the final extrusion step of transformed cells, similarly to actomyosin forces against apoptotic cells. As vimentin filaments do not colocalize with F-actin at the interface (Supplementary Fig. 9b), vimentin contractile forces are not mediated by actomyosin cytoskeletons, but possibly by other vimentin-binding proteins (Supplementary Fig. 1b).



Supplementary Figure 10 Activity of Rho-Rho kinase but not of myosin-II in the surrounding normal cells affects apical extrusion of transformed cells and filamin accumulation at the interface. (a) Establishment of MDCK cells stably expressing mCherry-RhoGAP in a tetracycline-inducible manner. The expression of mCherry-RhoGAP was not induced or induced by tetracycline for 24 h. Cell lysates were examined by western blotting with the indicated antibodies. (b) Establishment of MDCK cells stably expressing myc-tagged dominant negative Rho kinase. Cell lysates were examined by western blotting with the indicated antibodies. (c) Establishment of MDCK cells stably expressing a dominant negative form of myosin-II light chain (MLC-AA) in a tetracycline-inducible manner. The expression of GFP-MLC-AA was not induced or induced by tetracycline for 24 h. Cell lysates were examined by western blotting with the indicated antibodies. (d) Effect of overexpression of MLC-AA in the surrounding cells on apical extrusion of Src-transformed cells. MLC-AA expression was not induced or induced by tetracycline 4 h prior to v-Src activation. Data are mean $\pm$ s.e. from three independent experiments. (e) Effect of overexpression of MLC-AA in the surrounding cells on filamin accumulation at the interface with Src-transformed cells. MLC-AA expression was not induced or induced by tetracycline 4 h prior to v-Src activation. Data are mean $\pm$ s.e. from three independent experiments.



Supplementary Figure 11 Cellular stiffness of RasV12-transformed cells is higher than normal epithelial cells. Quantification of $\ln G_0$ (a), α (b) and μ (c) using atomic force microscopy (AFM). For RasV12 and RasV12-MLC-AA cells, RasV12 expression was induced for 16-18 h by tetracycline. Data are mean $\pm$ s.e.; n=48 cells for MDCK, 47 cells for RasV12, 49 cells for RasV12-MLC-AA. * $P=0.0023$, ** $P=3.7 \times 10^{-9}$ (a); * $P=0.011$, ** $P=3.1 \times 10^{-6}$ (b); * $P=0.0020$, ** $P=0.0085$ (c) (Student's *t*-test). The value of $\ln G_0$ or α that reflects elasticity was reverted by co-expression of MLC-AA in RasV12-expressing cells, whereas the value of μ that reflects viscosity was not. Detailed information on each parameter is described in Methods.



Supplementary Figure 12 Pulling forces are exerted on the interface between normal and transformed epithelial cells. (a) Representative images of laser-ablated MDCK (upper panels) or RasV12-transformed cells (lower panels) that are surrounded by MDCK cells. An inner region of the cell was irradiated with a 2-photon laser tuned to the 880 nm-wavelength. Images were taken every 2 s, and the images just before and after the irradiation are shown. CMFDA or GFP-RasV12 is shown in white. Red dashed lines delineate the cell area before irradiation. Yellow stars show the centre of the irradiated areas. Scale bar, 5 μ m. See also Supplementary Movies 4-6. (b) Quantification of the effect of laser ablation on the cell area. The ratio of cell areas after/before laser ablation was measured. Note that when pulling forces are exerted on the interface between the irradiated and neighbouring cells, the value will be above 1, whereas the value will be below 1 when the cells are pushing each other. Data are mean $\pm$ s.d. from 16 cells for MDCK, 13 cells for Src, and 15 cells for Ras. * $P=0.022$, ** $P=2.8 \times 10^{-4}$ (Welch's t -test).

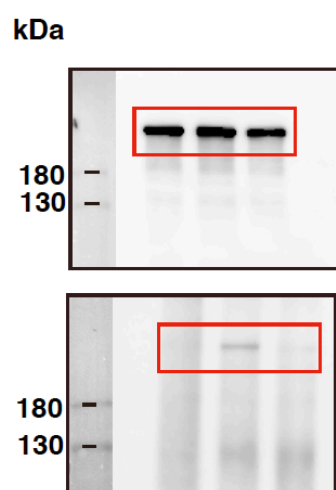

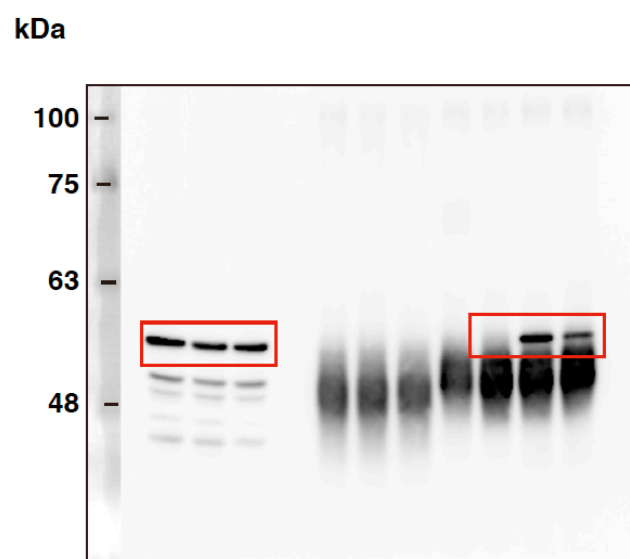
